**RESOLUTION NO. 2020-035**

**WHEREAS**, the Corporate Communication Department (CCD) requested the Bids and Awards Committee (BAC) for the **procurement of the services of a research/survey company to conduct the 2020 PhilGuarantee customer satisfaction survey** with an Approved Budget for the Contract (ABC) of **Pesos: Four Hundred Fifty Thousand (P450,000.00)**, inclusive of applicable taxes;

**WHEREAS**, CFA:138-10020 in the amount of **Pesos: Four Hundred Fifty Thousand (P450,000.00)** was issued by the Budget and Management Department for this purpose;

**WHEREAS**, the requested procurement is under the approved Philippine Guarantee Corporation Annual Procurement Plan (APP) for FY 2020-Updated, viz:

**WHEREAS**, in order to promote economy and efficiency, alternative methods of procurement may be resorted to in accordance with Section 48.1 of the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184 or the Government Procurement Reform Act, such as in this case;

**WHEREAS**, the item to be procured does not exceed the threshold prescribed in Section V.D.8.a.i of Annex H of the 2016 Revised IRR of RA No. 9184;

**WHEREAS**, Section V.D.8.b.ii. and iii of Annex H of the 2016 Revised IRR of RA No. 9184 provides that:

- “ii. BAC shall prepare and send the RFQs/RFPs to at least three (3) suppliers, contractors or consultants of known qualifications. This, notwithstanding, those who responded through any of the required postings shall be allowed to participate. Receipt of at least one (1) quotation is sufficient to proceed with the evaluation thereof.
- iii. Except for those with ABCs equal to Fifty Thousand Pesos (P50,000.00) and below, RFQs shall be posted for a period of three (3) calendar days in the PhilGEPS website, website of the Procuring Entity, if available, and at any conspicuous place reserved for this purpose in the premises of the Procuring Entity.”

**WHEREAS**, the Request for Quotation (RFQ) was posted on PhilGuarantee and PhilGEPS websites, on Philguarantee Bulletin Board and was sent to the following service providers on October 19, 2020:

1. Arc Docendi, Inc.;
2. Contract Asia Services, Inc.; and
3. Profiles Asia Pacific, Inc.

**WHEREAS**, the following service providers submitted quotations before the deadline on October 23, 2020, 2:00 p.m.;

1. Profiles Asia Pacific, Inc.; and
2. Premier Value Providers, Inc.


**WHEREAS**, the CCD determined that the quotation of **Premier Value Providers, Inc.** in the amount of **Pesos: Two Hundred Ninety Thousand (₱290,000.00)**, inclusive of applicable taxes to be the **Lowest Calculated and Responsive Quotation** to the requirements of the PhilGuarantee (copy of the Memorandum dated October 28, 2020 is herein attached as Annex "A") and recommended to the BAC its award;

**NOW THEREFORE**, in consideration of the recommendation of the Corporate Communication Department, the Bids and Awards Committee resolved to recommend the approval by the Head of the Procuring Entity of the following:

- a. The use of Small Value Procurement for the **procurement of the services of a research/survey company to conduct the 2020 PhilGuarantee customer satisfaction survey** with an Approved Budget for the Contract (ABC) of **Pesos: Four Hundred Fifty Thousand (₱450,000.00)**, inclusive of applicable taxes; and
- b. The award of contract to **Premier Value Providers, Inc.** for the procurement of the services of a research/survey company to conduct the 2020 PhilGuarantee customer satisfaction survey in the amount of **Pesos: Two Hundred Ninety Thousand (₱290,000.00)**, inclusive of applicable taxes.


