

Contract Agreement

THIS AGREEMENT made on the 9th day of November 2020 between **PHILIPPINE GUARANTEE CORPORATION**, represented herein by its President and Chief Executive Officer, **MR. ALBERTO E. PASCUAL** (hereinafter called "the Entity") of the one part and **PREMIER VALUE PROVIDER, INC.**, represented herein by its Director of Operations, **MS. ABIGAIL ANNE L. HINTO** (hereinafter called "the Supplier") of the other part:

WHEREAS the Entity invited Bids for certain goods and ancillary services, viz., *Procurement of the Services of a Research/Survey Company to Conduct the 2020 PHILGUARANTEE Customer Satisfaction Survey* and has accepted a Bid by the Supplier for the supply thereof in the sum of **TWO HUNDRED NINETY THOUSAND PESOS (P290,000.00)**, inclusive of all applicable taxes and other related fees (hereinafter called "the Contact Price").

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.
2. The following documents shall be deemed to form and be read and construed as part of this Agreement, viz.:
 - (a) the Supplier's Bid, including the Proposals and all other documents/statements submitted;
 - (b) the Request for Quotation;
 - (c) the Terms of Reference; and
 - (d) the Notice of Award.
3. In consideration of the payments to be made by the Entity to the Supplier as hereinafter mentioned, the Supplier hereby covenants with the Entity to provide the goods and services and to remedy defects therein in conformity in all respects with the provisions of the Contract
4. The Entity hereby covenants to pay the Supplier in consideration of the provision of the goods and services and the remedying of defects therein, the Contract Price or such other sum as may become payable under the provisions of the contract at the time and in the manner prescribed by the contract.


