R E S O L U T I O N N O . 2 0 2 0 - 0 7 6

WHEREAS, the Human Resource and Organizational Development Department (HRODD) requested the Bids and Awards Committee (BAC) for the procurement of supply and delivery of individually packed food items with an Approved Budget for the Contract (ABC) of **Pesos: Nine Hundred Ninety Thousand (Php990,000.00)**, inclusive of all applicable taxes;

WHEREAS, CFA:177-11020 in the amount of **Pesos: One Million Eighty Thousand (Php1,080,000.00)** was issued by the Comptrollership Group for this purpose;

WHEREAS, the requested procurement is under the approved Philippine Guarantee Corporation Annual Procurement Plan (APP) for FY 2020-Updated, viz:

WHEREAS, in order to promote economy and efficiency, alternative methods of procurement may be resorted to in accordance with Section 48.1 of the 2016 Revised Implementing Rules and Regulations of Republic Act No. 9184 or the Government Procurement Reform Act;

WHEREAS, the item to be procured does not exceed the threshold prescribed in Section V.D.8.a.i of Annex H of the 2016 Revised IRR of RA No. 9184;

WHEREAS, Section V.D.8.b.ii. and iii of Annex H of the 2016 Revised IRR of RA No. 9184 provides that:

- “ii. BAC shall prepare and send the RFQs/RFPs to at least three (3) suppliers, contractors or consultants of known qualifications. This, notwithstanding, those who responded through any of the required postings shall be allowed to participate. Receipt of at least one (1) quotation is sufficient to proceed with the evaluation thereof.

- iii. Except for those with ABCs equal to Fifty Thousand Pesos (P50,000.00) and below, RFQs shall be posted for a period of three (3) calendar days in the PhilGEPS website, website of the Procuring Entity, if available, and at any conspicuous place reserved for this purpose in the premises of the Procuring Entity.”

WHEREAS, the Request for Quotation (RFQ) was posted and sent on December 9, 2020 to the following service providers:

- a. Robinson Supermarket Corporation;
- b. All Day Supermarket; and
- c. Walter Mart Supermarket, Inc

WHEREAS, only Shopwise Makati (Robinson’s Supermarket Corporation) submitted quotation before the deadline on December 11, 2020; 2:00 p.m.;

WHEREAS, the HRODD determined that the quotation of **Shopwise Makati (Robinson’s Supermarket Corporation)** in the amount of **Pesos: Nine Hundred Seventy Eight Thousand Six Hundred Forty and 55/100 (Php978,640.55)**, inclusive of applicable taxes to be the **Single Calculated and Responsive Quotation** to the requirements of the PhilGuarantee (copy of the Memorandum dated December 15, 2020 is attached as Annex “A”) and recommended to the BAC its award;

NOW THEREFORE, in consideration of the recommendation of the Human Resource and Organizational Development Department, the Bids and Awards Committee resolved to recommend the approval by the Head of the Procuring Entity of the following:

- a. The use of **Small Value Procurement** for the procurement of supply and delivery of individually packed food items with an Approved Budget for the Contract (ABC) of **Pesos: Nine Hundred Ninety Thousand (Php990,000.00)**, inclusive of all applicable taxes; and
- b. The award of contract to **Shopwise Makati (Robinson's Supermarket Corporation)** for the procurement of supply and delivery of individually packed food items in the amount of **Pesos: Nine Hundred Seventy Eight Thousand Six Hundred Forty and 55/100 (Php978,640.55)**.
