## **RESOLUTION NO. 2021-015**

WHEREAS, the Facilities and General Services Department (FGSD) requested the Bids and Awards Committee (BAC) for the procurement of various toners for Laserjet Printers with an Approve Budget for the Contract (ABC) of Pesos: Sixty-One Thousand Pesos (Php61,000.00), inclusive of all applicable taxes;

WHEREAS, CFA:028-2021 in the amount of Pesos: Forty-Two Thousand Nine Hundred Fifty-Seven and 79/100 (Php42,957.79), was issued by the Budget Management Department for this purpose;

WHEREAS, the requested procurement is under the approved Philippine Guarantee Corporation Annual Procurement Plan (APP) for FY 2020-Updated, viz:

WHEREAS, in order to promote economy and efficiency, alternative methods of procurement may be resorted to in accordance with Section 48.1 of the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184 or the Government Procurement Reform Act;

WHEREAS, pursuant to Section V.C.1.b of Annex H of the 2016 Revised IRR of RA No. 9184, Shopping shall be employed for the procurement of ordinary or regular office supplies and equipment not available in the DBM-PS, in the amount not to exceed the One Million Pesos (₱1,000,000) for GOCCs;

**WHEREAS**, Section V.C.2.b.iv of Annex H of the 2016 Revised IRR of RA No. 9184 provides that:

"The BAC shall send the RFQs to at least three (3) suppliers of known qualifications, and at least three (3) price quotations must be obtained. This, notwithstanding, those who responded through any of the required postings shall be allowed to participate."

WHEREAS, the item to be procured does not exceed the threshold prescribed in Section V.C.1.b.i of Annex H of the 2016 Revised IRR of RA No. 9184;

WHEREAS, the Request for Quotation (RFQ) was sent to the following service providers on the following dates:

- e. Imax Technologies, Inc.; and

WHEREAS, Section 35.1ca) of the 2016 Revised Implementing Rules and Regulations of Republic Act No. 9184 provides that:

The BAC shall declare the bidding a failure when:

"All bids fail to comply with all the bid requirements or fail post-qualification, or, in the case of Consulting Services, there is no successful negotiation"

WHEREAS, the FGSD determined that all bids were not responsive with the requirements of the Corporation (copy of the Memorandum dated February 16, 2021 is herein attached as Annex "A") and recommended to the BAC the declaration of a failure of bidding, and requested for the re-posting of the Request for Quotation;

NOW THEREFORE, in consideration of the recommendation of the Facilities and General Services Department, the Bids and Awards Committee resolved the following:

- a. To declare a failure of bidding for the procurement of various toners for Laserjet Printers with an Approve Budget for the Contract (ABC) of **Pesos: Sixty-One Thousand Pesos (Php61,000.00),** inclusive of all applicable taxes; and
- b. To re-post the Request for Quotation for the procurement of various toners for Laserjet Printers with an Approve Budget for the Contract (ABC) of **Pesos: Sixty-One Thousand Pesos (Php61,000.00)**, inclusive of all applicable taxes.
