RESOLUTION NO. 2021-037

WHEREAS, the GAD Focal Point System (GFPS) - TWG requested the Bids and Awards Committee (BAC) for the procurement of customized GAD polo shirts with an Approved Budget for the Contract (ABC) of **Pesos: Seventy-Three Thousand Three Hundred Fifty (Php73,350.00)**, inclusive of all applicable taxes;

WHEREAS, CFA:050-2021 in the amount of **Pesos: One Hundred Fourteen Thousand Nine Hundred Ten (Php114,910.00)** was issued by the Budget Management Department for this purpose;

WHEREAS, the requested procurement is included in the Philippine Guarantee Corporation Annual Procurement Plan (APP) for FY 2021, viz:

WHEREAS, in order to promote economy and efficiency, alternative methods of procurement may be resorted to in accordance with Section 48.1 of the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184 or the Government Procurement Reform Act, such as in this case;

WHEREAS, the item to be procured does not exceed the threshold prescribed in Section V.D.8.a.i of Annex H of the 2016 Revised IRR of RA No. 9184;

WHEREAS, Section V.D.8.b.ii. and iii of Annex H of the 2016 Revised IRR of RA No. 9184 provides that:

- “ii. BAC shall prepare and send the RFQs/RFPs to at least three (3) suppliers, contractors or consultants of known qualifications. This, notwithstanding, those who responded through any of the required postings shall be allowed to participate. Receipt of at least one (1) quotation is sufficient to proceed with the evaluation thereof.

- iii. Except for those with ABCs equal to Fifty Thousand Pesos (P50,000.00) and below, RFQs shall be posted for a period of three (3) calendar days in the PhilGEPS website, website of the Procuring Entity, if available, and at any conspicuous place reserved for this purpose in the premises of the Procuring Entity.”

WHEREAS, the Request for Quotation (RFQ) was sent on February 24, 2021 to the following service providers:

1. Angels and Shirts Garments, Inc.;
2. Rulujac Enterprise; and
3. Stitch Active Enterprises

WHEREAS, the following suppliers submitted its quotation before the deadline of March 02, 2021; 2:00 P.M.;

1. Angels and Shirts Garments, Inc.; and
2. E&C General Merchandise


WHEREAS, the GAD FPS-TWG determined that the quotation of **Angels and Shirts Garments, Inc.**; in the amount of **Pesos: Sixty-Three Thousand Five Hundred Seventy (Php63,570.00)**, inclusive of all applicable taxes is the **Single Calculated and Responsive Quotation** to the requirements of the Corporation (copy of the Memorandum dated March 03, 2021 is herein attached as Annex "A") and recommended to the BAC its award;

NOW THEREFORE, in consideration of the recommendation of the GAD Focal Point System (GFPS) - TWG, the Bids and Awards Committee resolved to recommend the approval by the Head of the Procuring Entity of the following:

- a. The use of Small Value Procurement for the procurement of customized GAD polo shirts with an Approved Budget for the Contract (ABC) of **Pesos: Seventy-Three Thousand Three Hundred Fifty (Php73,350.00)**, inclusive of all applicable taxes; and
- b. The award of contract to **Angels and Shirts Garments, Inc.** for the procurement of customized polo shirt in the amount of **Pesos: Sixty-Three Thousand Five Hundred Seventy (Php63,570.00)**, inclusive of all applicable taxes.


