**WHEREAS**, the Information Technology Department (ITD) requested the Bids and Awards Committee (BAC) for the **Procurement of Executive and Productivity Laptops** with an Approved Budget for the Contract of **Pesos: Eight Million One Hundred Forty-Nine Thousand Eight Hundred (Php8,149,800.00)**, inclusive of applicable taxes;

**WHEREAS**, CFA-025-2021 in the amount of **Pesos: Eight Million One Hundred Forty-Nine Thousand Eight Hundred (Php8,149,800.00)** was issued by the Budget Management Department for this purpose;

**WHEREAS**, the requested procurement is under the approved Philippine Guarantee Corporation Annual Procurement Plan (APP) for FY 2021, viz:

**WHEREAS**, the Invitation to Bid was posted on the PHILGUARANTEE and PhilGEPS websites and at PHILGUARANTEE-Jade office Bulletin Board, for seven (7) calendar days;

**WHEREAS**, in response to the aforesaid invitation, the representatives from the following prospective bidder attended the pre-bid conference on 03 March 2021;

1. Advance Solutions, Inc.;
2. American Technologies Inc.;
3. Radenta Technologies Inc.;
4. SMS Global Technologies, Inc.;
5. Microgenesis Business Systems;
6. Quartz Business Products Corp.; and
7. AGD Infotech, Inc.;

**WHEREAS**, the following bidders submitted bid documents before the deadline on 15 March 2021; 1:15 P.M.:

1. Masangkay Computer Center; and
2. Pronet Systems Integrated Network Solution, Inc.

**WHEREAS**, during the opening of bids on 15 March 2021; 1:30 P.M., both bidders were determined to have "PASSED" the Technical Components (Eligibility and Technical Requirements) and Financial Components;

**WHEREAS**, Financial Bid were read as follows:

**WHEREAS**, on 18 March 2021, based on the bid evaluation and recommendation made by the TWG, the BAC declared the bid of Masangkay Computer Center in the amount of Pesos: Seven Million Eight Hundred Ninety-Two Thousand Two Hundred Twenty (Php7,892,220.00), inclusive of all applicable taxes as the **Lowest Calculated Bid**;

**WHEREAS**, upon verification, validation and ascertainment of the statements made and documents submitted by Masangkay Computer Center, the TWG determined that Masangkay Computer Center has passed all the criteria of the post-qualification (legal, technical and financial);

**WHEREAS**, on 30 March 2021, the TWG recommended Masangkay Computer Center to be declared as the **Lowest Calculated and Responsive Bid** and to be awarded of the contract;

**NOW, THEREFORE**, in consideration of the recommendation of the Technical Working Group, the Bids and Awards Committee (BAC), hereby **RESOLVE** as it is hereby **RESOLVED**:

- a) To declare the bid submission of **Masangkay Computer Center** as the **Lowest Calculated and Responsive Bid** for the **Procurement of Executive and Productivity Laptops/PGC-BAC-2021-002G**; and
- b) To recommend approval by the Head of the Procuring Entity (HoPE) the award of the contract for the **Procurement of Executive and Productivity Laptops/PGC-BAC-2021-002G** to **Masangkay Computer Center** in the amount of **Pesos: Seven Million Eight Hundred Ninety-Two Thousand Two Hundred Twenty (Php7,892,220.00)**, inclusive of all applicable taxes;
