## **RESOLUTION NO. 2021-091**

WHEREAS, the Facilities and General Services Department (FGSD) requested the Bids and Awards Committee (BAC) for the procurement of Batteries and Tires for the Service Vehicles of Philippine Guarantee Corporation with an Approved Budget for the contract (ABC) of Pesos: One Hundred Sixteen Thousand Four Hundred Fifty-Four (Php116,454.00), inclusive of all applicable taxes;

WHEREAS, CFA:076-2021 in the amount of One Hundred Sixteen Thousand Four Hundred Fifty-Four (Php116,454.00), was issued by the Budget Management Department (BMD) for this purpose;

WHEREAS, the requested procurement is included in the Philippine Guarantee Corporation Annual Procurement Plan (APP) for FY 2021, viz:

WHEREAS, in order to promote economy and efficiency, alternative methods of procurement may be resorted to in accordance with Section 48.1 of the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184 or the Government Procurement Reform Act, such as in this case;

WHEREAS, the item to be procured does not exceed the threshold prescribed in Section V.D.8.a.i of Annex H of the 2016 Revised IRR of RA No. 9184;

**WHEREAS**, Section V.D.8.b.ii. and iii of Annex H of the 2016 Revised IRR of RA No. 9184 provides that:

- "ii. BAC shall prepare and send the RFQs/RFPs to at least three (3) suppliers, contractors or consultants of known qualifications. This, notwithstanding, those who responded through any of the required postings shall be allowed to participate. Receipt of at least one (1) quotation is sufficient to proceed with the evaluation thereof.
- iii. Except for those with ABCs equal to Fifty Thousand Pesos (₱50,000.00) and below, RFQs shall be posted for a period of three (3) calendar days in the PhilGEPS website, website of the Procuring Entity, if available, and at any conspicuous place reserved for this purpose in the premises of the Procuring Entity."

**WHEREAS**, the Request for Quotation (RFQ) was posted and sent on May 14, 2021 to the following suppliers:

- 3. Equilast Inc.

**WHEREAS**, the following suppliers submitted their quotations before the deadline of May 14, 2021; 2:00 P.M.;

- 1. Achievers Sales Corporation received May 15, 2021, 2:30 P.M.;
- 2. Tire Asia Group Inc. received May 17, 2021, 4:32 P.M.;
- 3. Fleetserv Inc. received May 17, 2021, 9:35 P.M.;
- 4. EGMJ Trading received May 18, 2021, 10:00 A.M.:
- 5. Rogson Industrial Sales, Inc. May 18, 2021, 10:01 A.M.;

WHEREAS, Section 35.1ca) of the 2016 Revised Implementing Rules and Regulations of Republic Act No. 9184 provides that:

The BAC shall declare the bidding a failure when:

"All bids fail to comply with all the bid requirements or fail post-qualification, or, in the case of Consulting Services, there is no successful negotiation"

WHEREAS, the FGSD determined that all bids were not responsive with the requirements of the Corporation (copy of the Memorandum dated May 18, 2021 is herein attached as Annex "A") and recommended to the BAC the declaration of a failure of bidding and reposting of the Request for Quotation.

NOW THEREFORE, in consideration of the recommendation of the Facilities and General Services Department, the Bids and Awards Committee resolved the following:

- a. To declare a failure of bidding for the procurement of Batteries and Tires for the Service Vehicles of Philippine Guarantee Corporation with an Approved Budget for the contract (ABC) of Pesos: One Hundred Sixteen Thousand Four Hundred Fifty-Four (Php116,454.00), inclusive of all applicable taxes; and
- b. To repost the Request for Quotation for the procurement of Batteries and Tires for the Service Vehicles of Philippine Guarantee Corporation with an Approved Budget for the contract (ABC) of Pesos: One Hundred Sixteen Thousand Four Hundred Fifty-Four (Php116,454.00), inclusive of all applicable taxes.
