WHEREAS, Philcopy Corporation submitted its quotation on May 24, 2021 at 8:42 A.M. before the deadline of May 26, 2021; 2:00 P.M. in the amount Pesos: Four Hundred Ninety-Eight Thousand Four Hundred Thirty-Seven and 50/100 (Php498,437.50), inclusive of applicable taxes;

WHEREAS, the FGSD after evaluation of the quotation and submitted documents recommended the award of contract to Philcopy Corporation (copy of the Memorandum dated May 26, 2021 herein attached as Annex A);

**NOW THEREFORE**, in consideration of the recommendation of the Facilities and General Services Department, the Bids and Awards Committee resolved to recommend the approval by the Head of the Procuring Entity of the following:


