RESOLUTION NO. 2021-102

WHEREAS, the Human Resource and Organizational Development Department (HRODD) requested the Bids and Awards Committee (BAC) for the **Procurement of Manpower Services** with an Approved Budget for the Contract of **Pesos: Sixty-Six Million Four Hundred Seventeen Thousand Eight Hundred Seven and 85/100 (Php66,417,807.85), inclusive of administrative fees and applicable taxes**

WHEREAS, CFA-071-2021 in the amount of **Pesos: Sixty-Six Million Four Hundred Seventeen Thousand Eight Hundred Seven and 85/100 (Php66,417,807.85)** was issued by the Budget Management Department for this purpose;

WHEREAS, the requested procurement is under the approved Philippine Guarantee Corporation Annual Procurement Plan (APP) for FY 2021, viz:

WHEREAS, the Invitation to Bid was posted on the PHILGUARANTEE and PhilGEPS websites and at PHILGUARANTEE-Jade office bulletin board, for seven (7) calendar days;

WHEREAS, in response to the aforesaid invitation, the representatives from the following service providers attended the pre-bid conference on 12 May 2021;

1. **LSERV Corporation; and**
2. **Omniworx, Inc.**

WHEREAS, only **LSERV Corporation** submitted its bid documents on 24 May 2021; 10:17 A.M before the deadline on 24 May 2021; 1:15 P.M.;

WHEREAS, during the opening of bids on 24 May 2021; 1:30 P.M., **LSERV Corporation** was determined to have "PASSED" the Technical Components (Eligibility and Technical Requirements) and Financial Components;

WHEREAS, LSERV Corporation Financial Bid was read as follows:

WHEREAS, on 31 May 2021, based on the bid evaluation and recommendation made by the TWG, the BAC declared the bid of **LSERV Corporation** in the amount of **Pesos: Sixty-Three Million One Hundred Thirty-Seven Thousand Three Hundred Seventy-Two and 64/100 (Php63,137,372.64)**, inclusive of administrative fees and all applicable taxes as the **Single Calculated Bid**;

WHEREAS, on 11 June 2021, upon verification, validation and ascertainment of the statements made and documents submitted by **LSERV Corporation**, the TWG determined that **LSERV Corporation** has passed all the criteria of the post-qualification (legal, technical and financial) and recommended to declare **LSERV Corporation** as the **Single Calculated and Responsive Bid** and award the contract;

NOW, THEREFORE, in consideration of the recommendation of the Technical Working Group, the Bids and Awards Committee (BAC), hereby **RESOLVE** as it is hereby **RESOLVED** the following:

- a) To declare the bid submission of **LSERV Corporation** as the **Single Calculated and Responsive Bid** for the **Procurement of Manpower Services/PGC-BAC-2021-004G**; and
- b) To recommend approval by the Head of the Procuring Entity (HoPE) of the award of contract for the **Procurement of Manpower Services/PGC-BAC-2021-004G** to **LSERV Corporation** in the amount of **Pesos: Sixty-Three Million One Hundred Thirty-Seven Thousand Three Hundred Seventy-Two and 64/100 (Php63,137,372.64)**, inclusive of administrative fees and all applicable taxes.


