WHEREAS, the Facilities and General Services Department (FGSD) requested the Bids and Awards Committee (BAC) for the procurement of services for the Repair of PHILGUARANTEE Service Vehicle (Isuzu Altera with plate number ZPY-620) with an Approved Budget for the Contract (ABC) of Pesos: Fifty-Nine Thousand Three Hundred Sixty-Five (Php59,365.00), inclusive of applicable taxes;

WHEREAS, CFA:099-2021 in the amount of **Pesos: Fifty-Nine Thousand Three Hundred Sixty-Five (Php59,365.00)**, was issued by the Budget Management Department (BMD) for this purpose;

WHEREAS, the requested procurement is under the approved Philippine Guarantee Corporation Annual Procurement Plan (APP) for FY 2021, viz:

WHEREAS, in order to promote economy and efficiency, alternative methods of procurement may be resorted to in accordance with Section 48.1 of the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184 or the Government Procurement Reform Act, such as in this case;

WHEREAS, the item to be procured does not exceed the threshold prescribed in Section V.D.8.a.i of Annex H of the 2016 Revised IRR of RA No. 9184;

WHEREAS, Section V.D.8.b.ii. and iii of Annex H of the 2016 Revised IRR of RA No. 9184 provides that:

- "ii. BAC shall prepare and send the RFQs/RFPs to at least three (3) suppliers, contractors or consultants of known qualifications. This, notwithstanding, those who responded through any of the required postings shall be allowed to participate. Receipt of at least one (1) quotation is sufficient to proceed with the evaluation thereof.
- iii. Except for those with ABCs equal to Fifty Thousand Pesos (₱50,000.00) and below, RFQs shall be posted for a period of three (3) calendar days in the PhilGEPS website, website of the Procuring Entity, if available, and at any conspicuous place reserved for this purpose in the premises of the Procuring Entity."

WHEREAS, the Request for Quotation (RFQ) was sent on June 16, 2021 to the following service providers:

- 1. Valley South Motor Works;
- 2. Gerardo's Autoshop; and
- 3. Auto Camp Motors and Services.

WHEREAS, the following suppliers submitted quotations before the deadline of June 21, 2021; 2:00 P.M:

- 1. Valley South Motor Works received on June 21, 2021, 10:06 A.M.; and
- 2. Gerardo's Autoshop received on June 21, 2021, 11:07 A.M.

WHEREAS, the FGSD determined that the proposal of Valley South Motor Works in the amount of Pesos: Fifty-One Thousand One Hundred Sixty-One and 60/100 (Php51,161.60), inclusive of applicable taxes to be the Lowest Calculated and Responsive Quotation to the requirements of PHILGUARANTEE (copy of the Memorandum dated June 22, 2021 is attached as Annex "A") and recommended to the BAC its award;

NOW THEREFORE, in consideration of the recommendation of the Facilities and General Services Department, the Bids and Awards Committee resolved to recommend the approval by the Head of the Procuring Entity of the following:

- a. The use of Small Value Procurement for the procurement of services for the Repair of PHILGUARANTEE Service Vehicle (Isuzu Altera with plate number ZPY-620) with an Approved Budget for the Contract (ABC) of Pesos: Fifty-Nine Thousand Three Hundred Sixty-Five (Php59,365.00), inclusive of applicable taxes; and
- b. The award of contract to Valley South Motor Works for the procurement of services for the Repair of PHILGUARANTEE Service Vehicle (Isuzu Altera with plate number ZPY-620) in the amount of Pesos: Fifty-One Thousand One Hundred Sixty-One and 60/100 (Php51,161.60), inclusive of applicable taxes.
