

Contract Agreement Form

THIS AGREEMENT made the day of _____ 21 between **PHILIPPINE GUARANTEE CORPORATION** of Makati City, Philippines (hereinafter called "the Entity") of the one part and **EIAN MANAGEMENT CONSULTING SERVICES** of General Trias, Cavite , Philippines (hereinafter called "the Supplier") of the other part;

WHEREAS, the Entity invited Bids for certain goods and ancillary services, particularly **A TRAINING SERVICE PROVIDER TO CONDUCT TRAINING/SEMINAR FOR THE IMPROVEMENT OF INTEGRATED MANAGEMENT SYSTEM (IMS)** and has accepted a Bid by the Supplier for the supply of those goods and services in the sum of **One Hundred Forty-Seven Thousand (PHP 147,000.00)**, inclusive of all applicable taxes (hereinafter called "the Contract Price").

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.
2. The following documents as required by the 2016 Revised Implementing Rules and Regulations of Republic Act No. 9184 shall be deemed to form and be read and construed as integral part of this Agreement, viz.:
 - i. Bidding Documents
 - i. Terms of Reference;
 - ii. Supplier's Bid/Proposal, including the Technical and Financial Proposals, and all other documents/statements submitted;
 - iii. Supplemental or Bid Bulletins, if any;
 - ii. Winning bidder's bid, including Technical and Financial Proposals, and all other documents or statements submitted; Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted including corrections
 - iii. Notice of Award of Contract; and the Bidder's conforme thereto; and
 - iv. Other documents that may be required by existing laws and/or the Procuring Entity.
 - v. Winning bidder agrees that additional contract documents or in formation prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.



3. In consideration for the sum of **One Hundred Forty-Seven Thousand (PHP 147,000.00)**, inclusive of all applicable taxes, **EIAN MANAGEMENT CONSULTING SERVICES** agrees to deliver/provide **TRAINNG/SEMINAR FOR THE IMPROVMENT OF INTEGRATED MANAGEMENT SYSTEM (IMS)** in accordance with its Bid.
4. The **PHILIPPINE GUARANTEE CORPORATION** agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.


