R E S O L U T I O N N O . 2 0 2 1 - 1 6 5

WHEREAS, the Corporate Communication Department (CCD) requested the Bids and Awards Committee (BAC) for the procurement of services of a Research/Survey Company to conduct the 2021 Customer Satisfaction Survey with an Approved Budget for the Contract (ABC) of **Pesos: Six Hundred Twenty Thousand (Php620,000.00)**, inclusive of applicable taxes;

WHEREAS, CFA:153-2021 in the amount of **Pesos: Six Hundred Twenty Thousand (Php620,000.00)**, was issued by the Budget Management Department (BMD) for this purpose;

WHEREAS, the requested procurement is under the approved Annual Procurement Plan (APP) for FY 2021-Updated as of June 30, 2021-Supplemental 9, viz:

WHEREAS, in order to promote economy and efficiency, alternative methods of procurement may be resorted to in accordance with Section 48.1 of the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184 or the Government Procurement Reform Act, such as in this case;

WHEREAS, the item to be procured does not exceed the threshold prescribed in Section V.D.8.a.i of Annex H of the 2016 Revised IRR of RA No. 9184;

WHEREAS, Section V.D.8.b.ii. and iii of Annex H of the 2016 Revised IRR of RA No. 9184 provides that:

- “ii. BAC shall prepare and send the RFQs/RFPs to at least three (3) suppliers, contractors or consultants of known qualifications. This, notwithstanding, those who responded through any of the required postings shall be allowed to participate. Receipt of at least one (1) quotation is sufficient to proceed with the evaluation thereof.**

- iii. Except for those with ABCs equal to Fifty Thousand Pesos (P50,000.00) and below, RFQs shall be posted for a period of three (3) calendar days in the PhilGEPS website, website of the Procuring Entity, if available, and at any conspicuous place reserved for this purpose in the premises of the Procuring Entity.”**

WHEREAS, the Request for Quotation (RFQ) was posted and sent on October 1, 2021 to the following service providers:

1. CASI Research;
2. People Dynamics, Inc. (PDI);
3. Philippine Survey and Research Center (PSRC); and
4. Premiere Value Provider, Inc. (PVPI).

WHEREAS, Bid Bulletin No. 1 and Bid Bulletin No. 2 were posted on October 05, 2021 and on October 06, 2021, respectively;

WHEREAS, the following service providers submitted proposals before the deadline of October 07, 2021; 2:00 P.M.:

1. Adrow Creatives, Inc. received on October 07, 2021, 10:45 A.M.;
2. People Dynamics, Inc. received on October 07, 2021, 11:57 A.M.;
3. Premiere Value Provider, Inc. received on October 07, 2021, 12:05 P.M.;
4. Philippine Survey & Research Center Inc. received on October 07, 2021, 12:39 P.M.;
5. Acquisition Apps, Inc. received on October 07, 2021, 1:22 P.M.; and
6. Edgepoint Solutions, Inc. received on October 07, 2021, 1:58 P.M.

WHEREAS, the CCD determined that the proposal of **Philippine Survey & Research Center Inc.** in the amount of **Pesos: Five Hundred Forty-Eight Thousand Eight Hundred (Php548,800.00)**, inclusive of applicable taxes to be the **Highest Rated and Responsive Proposal** to the requirements of PHILGUARANTEE (copy of the Memorandum dated October 14, 2021 is attached as Annex "A") and recommended to the BAC its award;

NOW THEREFORE, in consideration of the recommendation of the Corporate Communication Department, the Bids and Awards Committee resolved to recommend the approval by the Head of the Procuring Entity of the following:

- a. The use of **Small Value Procurement** for the procurement of services of a Research/Survey Company to conduct the 2021 Customer Satisfaction Survey with an Approved Budget for the Contract (ABC) of **Pesos: Six Hundred Twenty Thousand (Php620,000.00)**, inclusive of applicable taxes; and
- b. The award of contract to **Philippine Survey & Research Center Inc.** for the procurement of services of a Research/Survey Company to conduct the 2021 Customer Satisfaction Survey in the amount of **Pesos: Five Hundred Forty-Eight Thousand Eight Hundred (Php548,800.00)**, inclusive of applicable taxes.


