RESOLUTION NO. 2021-169

WHEREAS, the Corporate Communications Department (CCD) requested the Bids and Awards Committee (BAC) for the procurement of Three (3) sets of Fifty-Five Inches (55") 4K Ultra HD, HDR, Smart Android Television with an Approved Budget for the contract (ABC) of **Pesos: One Hundred Seventy Thousand** (**Php170,000.00**), inclusive of all applicable taxes;

WHEREAS, CFA:154-2021 in the amount of **Pesos: One Hundred Seventy Thousand (Php170,000.00)**, was issued by the Budget Management Department (BMD) for this purpose;

WHEREAS, the requested procurement is under the approved Annual Procurement Plan (APP) for FY 2021-Updated as of June 30, 2021-Supplemental 9, viz:

Procurement Program/Project	Mode of Procurement	Estimated Budget (MOOE)
55" Smart Ultra HD Television	NP-53.9 - Small Value Procurement	Php223,850.00

WHEREAS, in order to promote economy and efficiency, alternative methods of procurement may be resorted to in accordance with Section 48.1 of the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184 or the Government Procurement Reform Act, such as in this case;

WHEREAS, the item to be procured does not exceed the threshold prescribed in Section V.D.8.a.i of Annex H of the 2016 Revised IRR of RA No. 9184;

WHEREAS, Section V.D.8.b.ii and iii of Annex H of the 2016 Revised IRR of RA No. 9184 provides that:

- "ii. BAC shall prepare and send the RFQs/RFPs to at least three (3) suppliers, contractors or consultants of known qualifications. This, notwithstanding, those who responded through any of the required postings shall be allowed to participate. Receipt of at least one (1) quotation is sufficient to proceed with the evaluation thereof.
- iii. Except for those with ABCs equal to Fifty Thousand Pesos (₱50,000.00) and below, RFQs shall be posted for a period of three (3) calendar days in the PhilGEPS website, website of the Procuring Entity, if available, and at any conspicuous place reserved for this purpose in the premises of the Procuring Entity."

WHEREAS, the Request for Quotation (RFQ) was posted and sent on October 7, 2021 to the following suppliers:

- 1. Abenson Ventures Inc.;
- 2. Ansons Makati;
- 3. Rustan Supercenter, Inc.; and
- 4. Sony Center Glorietta.

WHEREAS, only ULY Tech Trading submitted its proposal on October 11, 2021; 12:00 P.M. before the deadline of October 11, 2021; 2:00 P.M.;

WHEREAS, the CCD determined that the quotation of ULY Tech Trading was not responsive with the requirements of the Corporation (copy of the Memorandum dated October 15, 2021 is herein attached as Annex "A") and recommended to the BAC the declaration of a failure of bidding and reposting of the Request for Quotation.

WHEREAS, Section 35.1ca) of the 2016 Revised Implementing Rules and Regulations of Republic Act No. 9184 provides that:

The BAC shall declare the bidding a failure when:

"All bids fail to comply with all the bid requirements or fail post-qualification, or, in the case of Consulting Services, there is no successful negotiation"

NOW THEREFORE, in consideration of the recommendation of the Facilities and General Services Department, the Bids and Awards Committee resolved the following:

- a. To declare a failure of bidding for the procurement of Three (3) sets of Fifty-Five Inches (55") 4K Ultra HD, HDR, Smart Android Television with an Approved Budget for the contract (ABC) of **Pesos: One Hundred Seventy Thousand (Php170,000.00)**, inclusive of all applicable taxes; and
- b. To repost (2nd posting) the Request for Quotation for the procurement of Three (3) sets of Fifty-Five Inches (55") 4K Ultra HD, HDR, Smart Android Television with an Approved Budget for the contract (ABC) of **Pesos: One Hundred Seventy Thousand (Php170,000.00)**, inclusive of all applicable taxes.
