


CONTRACT AGREEMENT

THIS AGREEMENT, made this ____ day of October, 2021 between **PHILIPPINE GUARANTEE CORPORATION**, with principal office address at the 17/F BDO Towers, Valero Street, Makati City and 335 Jade building Sen Gil J. Puyat Ave, Makati City represented by its President & CEO, **ALBERTO E. PASCUAL**, hereinafter called the "**ENTITY**" and **FRENT ADVERTISING CONSULTANCY SERVICES**, represented by its Managing Director, **CHARLOTTE AIREEN F. PUNZALAN** of 131 Camella Road. Camella Homes 2. Talon Dos, Las Pinas City Philippines, hereinafter called the "**SUPPLIER**".

WHEREAS, the Entity invited Bids for certain goods and ancillary services, particularly the "**PROCUREMENT OF SERVICES OF A PROVIDER TO CONDUCT GENDER SENSITIVITY TRAINING**" and has accepted a Bid by the Supplier for the supply of those services in the sum of **Pesos: Sixty-Seven Thousand Two Hundred (Php67,200.00)**, hereinafter called "the Contract Price".

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.
 2. The following documents as required by the 2016 revised Implementing Rules and Regulations of Republic Act No. 9184 shall be deemed to form and be read and construed as integral part of this Agreement, viz.:
 - i. Bidding Documents
 - i. Request for Quotations;
 - ii. Technical Specifications; and
 - iii. Supplemental or Bid Bulletins, if any
 - ii. Winning bidder's bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted;

Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;
 - iii. Notice of Award of Contract; and the Bidder's *conforme* thereto; and
 - iv. Other contract documents that may be required by existing laws



and/or the Procuring Entity concerned in the PBDs. **Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.**

3. In consideration for the sum of **Pesos: Sixty-Seven Thousand Two Hundred (Php67,200.00)** or such other sums as may be ascertained, **FRENT ADVERTISING CONSULTANCY SERVICES** agrees to provide **SERVICES TO CONDUCT "GENDER SENSITIVITY TRAINING"** in accordance with its Bid.
4. The **PHILIPPINE GUARANTEE CORPORATION** agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.
