R E S O L U T I O N N O . 2 0 2 1 - 1 7 8

WHEREAS, pursuant to BAC Resolution 2021-055, the Head of the procuring Entity approved the award of contract for the procurement of periodic maintenance and repair of PHILGUARANTEE Service Vehicle (Toyota Camry with plate number PRQ-101) to C and S Automotive Service and Trading Center Co. being the Single Calculated and Responsive Quotation in the amount of Pesos: Sixty-Six Thousand (Php66,000.00), inclusive of all applicable taxes;

WHEREAS, C and S Automotive Service and Trading Center Co. in its Letter dated May 18, 2021 (copy as Annex A) decline the contract for the periodic maintenance and repair of PHILGUARANTEE Service Vehicle (Toyota Camry with plate number PRQ-101) due to untimely passing of the owner causing their operations to be put on hold;

WHEREAS, the Facilities and General Services Department in its Memorandum dated October 4, 2021 (copy as Annex B) requested for the cancellation of the award and recommended for the declaration of a failure of bidding;

WHEREAS, Section 40.3. of the 2016 Revised Implementing Rules and Regulation of Republic Act. No. 91 84 provides that:

“In the case of failure, refusal or inability of the bidder with the SCRB or SRRB to submit the documents required under Section 37.1 of this IRR or to enter into contract and post the required Performance Security, as provided in this Section, the BAC shall disqualify the said bidder, and shall declare the bidding a failure and conduct a rebidding with readvertisement and/or posting, as provided for in Sections 21 and 25 of this IRR. XXX”

NOW THEREFORE, having considered the foregoing circumstances, the Bids and Awards Committee resolved the following:

- a. To disqualify C and S Automotive Service and Trading Center Co.;
- b. To declare a failure of bidding for the procurement of periodic maintenance and repair of PHILGUARANTEE Service Vehicle (Toyota Camry with plate number PRQ-101) with an Approved Budget for the Contract (ABC) of Pesos: Seventy-Two Thousand Two Hundred Twenty-Nine (Php72,229.00), inclusive of all applicable taxes; and
- c. To request approval by the Head of the Procuring Entity of the cancellation of the award made pursuant to BAC Resolution No. 2021-055.
