**WHEREAS**, the Facilities and General Services Department (FGSD) requested the Bids and Awards Committee (BAC) for the procurement via Direct Contracting of toner cartridge for Kyocera printers for the Fourth (4<sup>th</sup>) Quarter of CY 2021 with an Approved Budget for the Contract (ABC) of **Pesos: Four Hundred Seventy-Eight Thousand Nine Hundred Twenty-Five (Php478,925.00)**, inclusive of applicable taxes;

**WHEREAS**, CFA:175-2021 in the amount of **Pesos: Four Hundred Seventy-Eight Thousand Nine Hundred Twenty-Five (Php478,925.00)**, was issued by the Budget Management Department (BMD) for this purpose;

**WHEREAS**, the requested procurement is under the approved Philippine Guarantee Corporation Annual Procurement Plan (APP) for FY 2021, viz:

**WHEREAS**, Section 50.c of the Revised Implementing Rules and Regulations of Republic Act No. 9184 or the Government Procurement Reform Act, provides that:

c.) Those sold by an exclusive dealer or manufacturer which does not have sub-dealers selling at lower prices and for which no suitable substitute can be obtained at more advantageous terms to the GoP.

**WHEREAS**, the FGSD determined that Philcopy Corporation is the exclusive distributor in marketing and servicing Kyocera Document Solution brand copiers, laser printers and multifunctional peripherals, including related consumables and spare parts in the Philippines as evidenced by a Sworn Certificate of Guarantee Exclusive Distributorship dated March 12, 2021;

**WHEREAS**, Philcopy Corporation submitted its quotation on November 3, 2021 at 4:15 P.M. before the deadline of November 8, 2021; 2:00 P.M. in the amount **Pesos: Four Hundred Seventy-Eight Thousand Nine Hundred Twenty-Five (Php478,925.00)**, inclusive of applicable taxes;

**WHEREAS**, the FGSD recommended the Award of contract to Philcopy Corporation (copy of the memorandum dated November 5, 2021 herein attached as Annex A);

**NOW THEREFORE**, in consideration of the recommendation of the Facilities and General Services Department, the Bids and Awards Committee resolved to recommend the approval by the Head of the Procuring Entity of the following:

1. The use of **Alternative Mode of Procurement-Direct Contracting** for the procurement via Direct Contracting of toner cartridge for Kyocera printers for the Fourth (4<sup>th</sup>) Quarter of CY 2021 with an Approved Budget for the Contract (ABC) of **Pesos: Four Hundred Seventy-Eight Thousand Nine Hundred Twenty-Five (Php478,925.00)**, inclusive of applicable taxes; and
2. The award of contract to **Philcopy Corporation** for the procurement via Direct Contracting of toner cartridge for Kyocera printers for the Fourth (4<sup>th</sup>) Quarter of CY 2021 in the amount of **Pesos: Four Hundred Seventy-Eight Thousand Nine Hundred Twenty-Five (Php478,925.00)**, inclusive of applicable taxes.
