

## CONTRACT AGREEMENT

THIS AGREEMENT, made this OCT 28 2021 day of October, 2021 between **PHILIPPINE GUARANTEE CORPORATION (PHILGUARANTEE)** (hereinafter called the "Entity") and **MICROGENESIS SOFTWARE INC.** doing under the name and style of **MICROGENESIS BUSINESS SYSTEMS**, with business address at Unit 1202 Paragon Plaza Bldg., 162 Edsa corner Reliance, Barangka Ilaya, Mandaluyong City, Philippines (hereinafter called the "Supplier").

WHEREAS the Entity invited Bids for certain goods and ancillary services, viz, the **ENDPOINT SECURITY SOFTWARE LICENSES/ PGC-BAC-2021-005G** (hereinafter called "the Works") and has accepted a Bid by the Supplier for the supply of those goods and services in the sum of **NINE HUNDRED EIGHTY THOUSAND EIGHT HUNDRED NINETY SIX PESOS (Php980,896.00)** (hereinafter called "the Contract Price"), inclusive of all applicable taxes by the Supplier for the execution and completion of such services and the remedying of any defects therein.

    - (h) Eligibility requirements, documents and/or statements;
    - (i) Performance Security; and
    - (j) Notice of Award of Contract and the Bidder's conforme thereto.

The Entity hereby covenants to pay the Supplier in consideration of the provision of the goods and services and the remedying of defects therein, the Contract Price or such other sum as may become payable under the provisions of the contract at the time and in the manner prescribed by the contract.


