R E S O L U T I O N N O. 2021-207

WHEREAS, the Corporate Communications Department (CCD) requested the Bids and Awards Committee (BAC) for the third posting for the procurement of Three (3) sets of Fifty-Five Inches (55") 4K Ultra HD, HDR, Smart Android Television an Approved Budget for the Contract (ABC) of **Pesos: One Hundred Seventy Thousand (Php170,000.00)**, inclusive of all applicable taxes;

WHEREAS, CFA:154-2021 in the amount **Pesos: One Hundred Seventy Thousand (Php170,000.00)**, was issued by the Budget Management Department (BMD) for this purpose;

WHEREAS, the requested procurement is under the approved Philippine Guarantee Corporation Annual Procurement Plan (APP) for FY 2021 Updated as of June 30, 2021-Supplemental 9, viz:

WHEREAS, in order to promote economy and efficiency, alternative methods of procurement may be resorted to in accordance with Section 48.1 of the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184 or the Government Procurement Reform Act, such as in this case;

WHEREAS, the item to be procured does not exceed the threshold prescribed in Section V.D.8.a.i of Annex H of the 2016 Revised IRR of RA No. 9184;

WHEREAS, Section V.D.8.b.ii and iii of Annex H of the 2016 Revised IRR of RA No. 9184 provides that:

- “ii. BAC shall prepare and send the RFQs/RFPs to at least three (3) suppliers, contractors or consultants of known qualifications. This, notwithstanding, those who responded through any of the required postings shall be allowed to participate. Receipt of at least one (1) quotation is sufficient to proceed with the evaluation thereof.
- iii. Except for those with ABCs equal to Fifty Thousand Pesos (P50,000.00) and below, RFQs shall be posted for a period of three (3) calendar days in the PhilGEPs website, website of the Procuring Entity, if available, and at any conspicuous place reserved for this purpose in the premises of the Procuring Entity.”

WHEREAS, the Request for Quotation (3rd Posting) was posted and sent on November 16, 2021 to the following suppliers:

1. 16/35mm Production Supply;
2. Avid Sales Corporation;
3. Jilijhen Enterprises;
4. Red-Com Enterprises; and
5. Uly Tech Trading.

WHEREAS, the following suppliers submitted quotations before the deadline of November 22, 2021; 2:00 P.M:

1. Avid Sales Corporation received on November 19, 2021, 5:43 P.M.;
2. 16/35mm Production Supply received on November 22, 2021, 11:23 A.M.; and
3. The Brain Computer Corporation received on November 22, 2021, 12:38 P.M.

WHEREAS, the CCD determined that the proposal of **The Brain Computer Corporation** in the amount of **Pesos: One Hundred Fifty-Nine Thousand (Php159,000.00)**, inclusive of applicable taxes to be the **Lowest Calculated and Responsive Quotation** to the requirements of PHILGUARANTEE (copy of the Memorandum dated November 24, 2021 is attached as Annex "A") and recommended to the BAC its award;

NOW THEREFORE, in consideration of the recommendation of the Corporate Communications Department, the Bids and Awards Committee resolved to recommend the approval by the Head of the Procuring Entity of the following:

- a. The use of **Small Value Procurement** for the procurement of Three (3) sets of Fifty-Five Inches (55") 4K Ultra HD, HDR, Smart Android Television an Approved Budget for the Contract (ABC) of **Pesos: One Hundred Seventy Thousand (Php170,000.00)**, inclusive of all applicable taxes; and
- b. The award of contract to **The Brain Computer Corporation** for the procurement of Three (3) sets of Fifty-Five Inches (55") 4K Ultra HD, HDR, Smart Android Television in the amount of **Pesos: One Hundred Fifty-Nine Thousand (Php159,000.00)**, inclusive of applicable taxes.
