WHEREAS, the Human Resource and Organizational Development Department (HRODD) requested the Bids and Awards Committee (BAC) for the procurement of the Supply and Delivery of Individually Packed Food Items, as follows:

Lot	Quantity	Approved Budget for the Contract (Inclusive of applicable taxes)
1	213 packs	PESOS: Six Hundred Thirty-Nine Thousand (Php639,000.00)
2	179 packs	PESOS: Three Hundred Fifty-Eight Thousand (Php358,000.00)

WHEREAS, CFA: 189-2021 in the amount of **Pesos: Nine Hundred Ninety-Seven Thousand (Php997,000.00)**, was issued by the Budget Management Department (BMD) for this purpose;

WHEREAS, the requested procurement is under the approved Philippine Guarantee Corporation Annual Procurement Plan (APP) for FY 2021, viz:

WHEREAS, in order to promote economy and efficiency, alternative methods of procurement may be resorted to in accordance with Section 48.1 of the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184 or the Government Procurement Reform Act, such as in this case;

WHEREAS, the item to be procured does not exceed the threshold prescribed in Section V.D.8.a.i of Annex H of the 2016 Revised IRR of RA No. 9184;

WHEREAS, Section V.D.8.b.ii and iii of Annex H of the 2016 Revised IRR of RA No. 9184 provides that:

- “ii. BAC shall prepare and send the RFQs/RFPs to at least three (3) suppliers, contractors or consultants of known qualifications. This, notwithstanding, those who responded through any of the required postings shall be allowed to participate. Receipt of at least one (1) quotation is sufficient to proceed with the evaluation thereof.
- iii. Except for those with ABCs equal to Fifty Thousand Pesos (P50,000.00) and below, RFQs shall be posted for a period of three (3) calendar days in the PhilGEPS website, website of the Procuring Entity, if available,

and at any conspicuous place reserved for this purpose in the premises of the Procuring Entity.”

WHEREAS, the Request for Quotation (RFQ) was posted and sent on November 16, 2021 to the following suppliers:

1. Allday Supermarket – Taguig Branch;
2. Pingcon Marketing;
3. Puregold Price Club Inc. – Makati Branch; and
4. Waltermart Edsa.

WHEREAS, only Puregold Price Club Inc. – Makati Branch submitted its proposal on November 22, 2021, 1:34 P.M. before the deadline of November 22, 2021; 2:00 P.M.;

WHEREAS, the HRODD determined that the quotations for both Lots 1 and 2 of **Puregold Price Club Inc. – Makati Branch** to be the **Single Calculated and Responsive Quotation** to the requirements of PHILGUARANTEE (copy of the Memorandum dated November 26, 2021 is attached as Annex “A”) and recommended to the BAC its award;

NOW THEREFORE, in consideration of the recommendation of the Human Resource and Organizational Development Department, the Bids and Awards Committee resolved to recommend the approval by the Head of the Procuring Entity of the following:
