WHEREAS, the Gender and Development Focal Point System Technical Working Group (GAD-FPTWG) in its Memorandum dated February 26, 2020, copy attached as Annex "A", requested the Bids and Awards Committee (BAC) to procure customized polo shirts for the 2020 National Women's Month Celebration;

WHEREAS, the Bids and Awards Committee (BAC) recommended the use of alternative mode of procurement through Small Value Procurement as provided for in Section 53.9 of the Revised Implementing Rules and Regulations of Republic Act No. 9184;

WHEREAS, the Request for Quotation was posted in the PhilGuarantee Bulletin Boards, PhilGuarantee Website, and Philippine Government Electronic Procurement System Website and sent to four (4) suppliers, namely: 1.) Stitch Active Enterprises; 2) Ceboom Enterprises; 3) SVC Clothing; and 4) Angels and Shirt Garments, Inc.;

WHEREAS, Stitch Active Enterprises, Ceboom Enterprises, Inc., SVC Clothing, and Angels and Shirt Garments, Inc. submitted proposals on or before the deadline;

WHEREAS, the GAD-FPTWG determined that the proposal of Angels and Shirt Garments, Inc. is the Lowest Calculated and Responsive Quotation to the requirements of PhilGuarantee (copy of the Memorandum dated March 9, 2020 is herein attached as Annex "B") and recommended to the BAC its award;




