WHEREAS, the Invitation to Bid was posted on the PHILGUARANTEE and PhilGEPS websites and at PHILGUARANTEE-Jade office Bulletin Board, for seven (7) calendar days;

WHEREAS, in response to the aforesaid invitation, only a representative from Omniworx, Inc. attended the pre-bid conference on 28 December 2020;

WHEREAS, only Omniworx, Inc. submitted bid documents before the deadline on 11 January 2021; 1:00 P.M.;

WHEREAS, during the opening of bids on 11 January 2021; 1:15 P.M., Omniworx, Inc. was determined to have "PASSED" the Technical Components (Eligibility and Technical Requirements) and Financial Components;

WHEREAS, Omniworx, Inc.'s Financial Bid was read as follows:

WHEREAS, on 18 January 2021, based on the bid evaluation and recommendation made by the TWG, the BAC declared the bid of Omniworx, Inc. in the amount of Pesos: Four Million Two Hundred Thirty-Five Thousand One Hundred Thirty-Six Pesos and 98/100 (Php4,235,136.98), inclusive of all applicable taxes as the Single Calculated Bid;

WHEREAS, pursuant to BAC Resolution 2021-004, the Head of the Procuring Entity as recommended by the BAC, approved an extension of until 11 February 2021 for the TWG to complete the post-qualification in view of the exceptional circumstances brought about by the COVID-19 pandemic;

WHEREAS, on 11 February 20211, the TWG, upon verification, validation and ascertainment of the statements made and documents submitted by Omniworx, Inc. determined that the documents submitted by Omniworx, Inc. passed all the criteria of the post-qualification (legal, technical and financial), and recommended that said bid be declared as the Single Calculated and Responsive Bid and that the contract be awarded to Omniworx, Inc.;

NOW, THEREFORE, in consideration of the recommendation of the Technical Working Group, the Bids and Awards Committee (BAC), hereby **RESOLVE** as it is hereby **RESOLVED**:

- a) To declare the bid submission of **Omniworx, Inc.** as the **Single Calculated** and **Responsive Bid** for the **Procurement of Janitorial Services Requirement of PhilGuarantee for CY 2020-2021**; and
- b) To recommend the award by the Head of the Procuring Entity (HoPE) of the contract for the **Procurement of Janitorial Services Requirement of PhilGuarantee for CY 2020-2021** to **Omniworx, Inc.** in the amount of **Pesos: Four Million Two Hundred Thirty-Five Thousand One Hundred Thirty-Six Pesos and 98/100 (Php4,235,136.98), inclusive of all applicable taxes**.
