RESOLUTION NO. 2021-026

WHEREAS, the Facilities and General Services Department (FGSD) requested the Bids and Awards Committee (BAC) for the procurement of tires and batteries with an Approved Budget for the Contract (ABC) of **Pesos: Eighty Thousand Sixty-One Pesos Only (Php80,061.00)**, inclusive of all applicable taxes;

WHEREAS, CFA:019-2021 in the amount of **Pesos: Eighty Thousand Sixty-One Pesos Only (Php80,061.00)** was issued by the Budget Management Department for this purpose;

WHEREAS, the requested procurement is included in the Philippine Guarantee Corporation Annual Procurement Plan (APP) for FY 2021, viz:

WHEREAS, the item to be procured does not exceed the threshold prescribed in Section V.D.8.a.i of Annex H of the 2016 Revised IRR of RA No. 9184;

WHEREAS, Section V.D.8.b.ii. and iii of Annex H of the 2016 Revised IRR of RA No. 9184 provides that:

- “ii. BAC shall prepare and send the RFQs/RFPs to at least three (3) suppliers, contractors or consultants of known qualifications. This, notwithstanding, those who responded through any of the required postings shall be allowed to participate. Receipt of at least one (1) quotation is sufficient to proceed with the evaluation thereof.
- iii. Except for those with ABCs equal to Fifty Thousand Pesos (₱50,000.00) and below, RFQs shall be posted for a period of three (3) calendar days in the PhilGEPS website, website of the Procuring Entity, if available, and at any conspicuous place reserved for this purpose in the premises of the Procuring Entity.”

WHEREAS, the following suppliers submitted its quotation before the deadline of February 2, 2021; 2:00 P.M.;

1. Achievers Sales Corporation received February 02, 2021 at 10:54 A.M.; and
2. Ganche Trading received February 02, 2021 at 1:55 P.M.

WHEREAS, the FGSD determined that the quotation of **Achievers Sales Corporation** in the amount of **Pesos: Seventy-Two Thousand Nine Hundred Seventy-Four (Php72,974.00)**, inclusive of all applicable taxes is the **Lowest Calculated and Responsive Quotation** to the requirements of the Corporation (copy of the Memorandum dated February 18, 2021 is herein attached as Annex "A") and recommended to the BAC its award;

NOW THEREFORE, in consideration of the recommendation of the Facilities and General Services Department, the Bids and Awards Committee resolved to recommend the approval by the Head of the Procuring Entity of the following:

- a. The use of Small Value Procurement for the procurement of tires and batteries with an Approved Budget for the Contract (ABC) of **Pesos: Eighty Thousand Sixty-One Pesos Only (Php80,061.00)**, inclusive of all applicable taxes; and
- b. The award of contract to **Achievers Sales Corporation** for the procurement of of tires and batteries in the amount of **Pesos: Seventy-Two Thousand Nine Hundred Seventy-Four (Php72,974.00)**, inclusive of all applicable taxes.


