R E S O L U T I O N N O. 2021-215

WHEREAS, the Human Resource and Organizational Development Department (HRODD) requested the Bids and Awards Committee (BAC) for the procurement of Raffle Prizes for PHILGUARANTEE's 2021 Thanksgiving Celebration with an Approved Budget for the contract (ABC) of **Pesos: Two Hundred Eighty-Five Thousand (Php285,000.00)**, inclusive of all applicable taxes;

WHEREAS, CFA: 203-2021 in the amount of **Pesos: Two Hundred Eighty-Five Thousand (Php285,000.00)**, was issued by the Budget Management Department (BMD) for this purpose;

WHEREAS, the requested procurement is included in the Annual Procurement Plan (APP) for FY 2021 - Updated as of June 30, 2021 (Supplemental 12), viz:

WHEREAS, in order to promote economy and efficiency, alternative methods of procurement may be resorted to in accordance with Section 48.1 of the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184 or the Government Procurement Reform Act, such as in this case;

WHEREAS, the item to be procured does not exceed the threshold prescribed in Section V.D.8.a.i of Annex H of the 2016 Revised IRR of RA No. 9184;

WHEREAS, Section V.D.8.b.ii and iii of Annex H of the 2016 Revised IRR of RA No. 9184 provides that:

- “ii. BAC shall prepare and send the RFQs/RFPs to at least three (3) suppliers, contractors or consultants of known qualifications. This, notwithstanding, those who responded through any of the required postings shall be allowed to participate. Receipt of at least one (1) quotation is sufficient to proceed with the evaluation thereof.

- iii. Except for those with ABCs equal to Fifty Thousand Pesos (P50,000.00) and below, RFQs shall be posted for a period of three (3) calendar days in the PhilGEPS website, website of the Procuring Entity, if available, and at any conspicuous place reserved for this purpose in the premises of the Procuring Entity.”

WHEREAS, the Request for Quotation (RFQ) was posted and sent on November 25, 2021 to the following suppliers:

1. Abenson Ventures, Inc. - Cainta;
2. Western Appliances - P. Tuazon Cubao; and
3. Xtreme Appliance.

WHEREAS, only Western Appliances - P. Tuazon Cubao submitted its quotation on November 29, 2021; 12:15 P.M. before the deadline of November 29, 2021; 2:00 P.M:

WHEREAS, the HRODD determined that the quotation of **Western Appliances - P. Tuazon Cubao** in the amount of **Pesos: Two Hundred Eighty-Four Thousand Nine Hundred Twenty (Php284,920.00)**, inclusive of applicable taxes to be the **Single Calculated and Responsive Quotation** to the requirements of PHILGUARANTEE (copy of the Memorandum dated December 2, 2021 is attached as Annex "A") and recommended to the BAC its award;

NOW THEREFORE, in consideration of the recommendation of the Human Resource and Organizational Development Department, the Bids and Awards Committee resolved to recommend the approval by the Head of the Procuring Entity of the following:

- a. The use of **Small Value Procurement** for the procurement of Raffle Prizes for PHILGUARANTEE's 2021 Thanksgiving Celebration with an Approved Budget for the contract (ABC) of **Pesos: Two Hundred Eighty-Five Thousand (Php285,000.00)**, inclusive of all applicable taxes; and
- b. The award of contract to **Western Appliances - P. Tuazon Cubao** for the procurement of Raffle Prizes for PHILGUARANTEE's 2021 Thanksgiving Celebration in the amount of **Pesos: Two Hundred Eighty-Four Thousand Nine Hundred Twenty (Php284,920.00)**, inclusive of all applicable taxes.
