R E S O L U T I O N N O. 2021-230

WHEREAS, the Corporate Communications Department (CCD) requested the Bids and Awards Committee (BAC) for the procurement of Branding Paraphernalia (Corporate Jackets, Corporate Polo Shirts, and Corporate Caps) with an Approved Budget for the contract (ABC) of **Pesos: Six Hundred Thousand (Php600,000.00)**, inclusive of all applicable taxes;

WHEREAS, CFA:206-2021 in the amount of **Pesos: Six Hundred Thousand (Php600,000.00)**, was issued by the Budget Management Department (BMD) for this purpose;

WHEREAS, the requested procurement is included in the Philippine Guarantee Corporation Annual Procurement Plan (APP) for FY 2021-Updated as of June 30, 2021 (Supplemental 12), viz:

WHEREAS, in order to promote economy and efficiency, alternative methods of procurement may be resorted to in accordance with Section 48.1 of the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184 or the Government Procurement Reform Act, such as in this case;

WHEREAS, the item to be procured does not exceed the threshold prescribed in Section V.D.8.a.i of Annex H of the 2016 Revised IRR of RA No. 9184;

WHEREAS, Section V.D.8.b.ii and iii of Annex H of the 2016 Revised IRR of RA No. 9184 provides that:

- “ii. BAC shall prepare and send the RFQs/RFPs to at least three (3) suppliers, contractors or consultants of known qualifications. This, notwithstanding, those who responded through any of the required postings shall be allowed to participate. Receipt of at least one (1) quotation is sufficient to proceed with the evaluation thereof.

- iii. Except for those with ABCs equal to Fifty Thousand Pesos (₱50,000.00) and below, RFQs shall be posted for a period of three (3) calendar days in the PhilGEPS website, website of the Procuring Entity, if available, and at any conspicuous place reserved for this purpose in the premises of the Procuring Entity.”

WHEREAS, the Request for Quotation (RFQ) was posted on November 29, 2021 and sent on December 1, 2021 the following dates to the following suppliers:

1. Artistika Corporate Giveaways;
2. Corporate Giveaways Online Inc.;
3. Tailored Projects; and
4. Transfer It.

WHEREAS, the sample design layout was posted on December 2, 2021;

WHEREAS, the following suppliers submitted quotations before the deadline December 6, 2021; 2:00 P.M.:

1. Karen International Inc. received on December 06, 2021, 8:27 A.M.;
2. Corevisory Enterprises Co. received on December 06, 2021, 8:49 A.M.;
3. Jen Lin Corporate Giveaways received on December 06, 2021, 12:07 P.M.;
4. Tanjer Enterprises received on December 06, 2021, 1:21 P.M.; and
5. Grand Success International Ventures Corporation received on December 06, 2021, 1:54 P.M.

WHEREAS, the CCD determined that all quotations failed to complied with the requirements of PHILGUARANTEE (copy of the Memorandum dated December 13, 2021 is attached as Annex "A") and recommended to the BAC the declaration of a failure of bidding;

WHEREAS, Section 35.1 a) of the 2016 Revised Implementing Rules and Regulations of Republic Act No. 9184 provides that:

The BAC shall declare the bidding a failure when:

"All bids fail to comply with all the bid requirements or fail post-qualification, or, in the case of Consulting Services, there is no successful negotiation"

NOW THEREFORE, in consideration of the recommendation of the Corporate Communications Department, the Bids and Awards Committee resolved to declare a failure of bidding for the procurement of Branding Paraphernalia (Corporate Jackets, Corporate Polo Shirts, and Corporate Caps) with an Approved Budget for the contract (ABC) of **Pesos: Six Hundred Thousand (Php600,000.00)**, inclusive of all applicable taxes.
