

CONTRACT AGREEMENT

THIS AGREEMENT made the DEC 16 2021 day of December 2021 between **PHILIPPINE GUARANTEE CORPORATION** of the Philippines (hereinafter called "the Entity") of the one part and **ROXAS FOOD VENTURES, INC.** of 432 San Andres St., Malate, Manila City, Philippines (hereinafter called "the Supplier") of the other part;

WHEREAS, the Entity invited Bids for certain goods and ancillary services, particularly the **PROCUREMENT OF INDIVIDUALLY PACKED MEALS** and has accepted a Bid by the Supplier for the supply of those goods and services in the sum of **Pesos: Two Hundred Seventy-Four Thousand Nine Hundred Fifty (Php 274,950.00)**, inclusive of applicable taxes (hereinafter called "the Contract Price"), specified as follows:

Lot	Quantity	Contract Amount (Inclusive of applicable taxes)
1	400	PESOS: Two Hundred Sixty Thousand (Php260,000.00)
2	23	PESOS: Fourteen Thousand Nine Hundred Fifty (Php14,950.00)

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.
2. The following documents as required by the 2016 revised Implementing Rules and Regulations of Republic Act No. 9184 shall be deemed to form and be read and construed as integral part of this Agreement, viz.:
 - i. Terms of Reference;
 - ii. Request for Quotation;
 - iii. Winning bidder's proposal;
 - iv. Notice of Award of Contract; and the Bidder's conforme thereto; and
 - v. Other related documents in relation to bid. **Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.**
3. In consideration for the sum of **Pesos: Two Hundred Seventy-Four Thousand Nine Hundred Fifty (Php 274,950.00)**, inclusive of applicable taxes or such other sums as may be ascertained, **ROXAS FOOD VENTURES, INC.** agrees to the **PROCUREMENT OF INDIVIDUALLY PACKED MEALS** in accordance with his/her/its Bid.
4. The **PHILIPPINE GUARANTEE CORPORATION** agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.


