R E S O L U T I O N N O. 2022-006

WHEREAS, the Human Resource and Organizational Development Department (HRODD) requested the Bids and Awards Committee (BAC) for the procurement of individually packed meals for PHILGUARANTEE’s 45th founding anniversary celebration with an Approved Budget for the Contract (ABC) of **Pesos: One Hundred Thirty Thousand Five Hundred Fifty (Php130,550.00)**, inclusive of applicable taxes;

WHEREAS, CFA: 009-2022 in the amount of **Pesos: One Hundred Thirty Thousand Five Hundred Fifty (Php130,550.00)**, was issued by the Budget Management Department (BMD) for this purpose;

WHEREAS, the requested procurement is included in the Philippine Guarantee Corporation Annual Procurement Plan (APP) for FY 2022 – Supplemental 1, viz:

WHEREAS, in order to promote economy and efficiency, alternative methods of procurement may be resorted to in accordance with Section 48.1 of the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184 or the Government Procurement Reform Act, such as in this case;

WHEREAS, the item to be procured does not exceed the threshold prescribed in Section V.D.8.a.i of Annex H of the 2016 Revised IRR of RA No. 9184;

WHEREAS, Section V.D.8.b.ii and iii of Annex H of the 2016 Revised IRR of RA No. 9184 provides that:

- “ii. BAC shall prepare and send the RFQs/RFPs to at least three (3) suppliers, contractors or consultants of known qualifications. This, notwithstanding, those who responded through any of the required postings shall be allowed to participate. Receipt of at least one (1) quotation is sufficient to proceed with the evaluation thereof.
- iii. Except for those with ABCs equal to Fifty Thousand Pesos (₱50,000.00) and below, RFQs shall be posted for a period of three (3) calendar days in the PhilGEPS website, website of the Procuring Entity, if available, and at any conspicuous place reserved for this purpose in the premises of the Procuring Entity.”

WHEREAS, the Request for Quotation (RFQ) was posted and sent on January 26, 2022 to the following suppliers:

1. Kenny Rogers Roasters;
2. Max's Kitchen, Inc.;
3. Roxas Food Ventures, Inc.; and
4. Savory Fastfood Inc.

WHEREAS, the Bid Bulletin number 1 was posted on January 28, 2022;

WHEREAS, the following suppliers submitted quotations before the deadline of January 31, 2022; 2:00 P.M:

1. Max's Kitchen, Inc. received on January 26, 2022, 5:56 P.M.;
2. Roxas Food Ventures Inc. received on January 28, 2022, 4:16 P.M.; and
3. ERP Wellness Enterprises received on January 29, 2022, 10:38 A.M.

WHEREAS, the HRODD determined that the quotation of **Max's Kitchen, Inc.** in the amount of **Pesos: One Hundred Twenty-Eight Thousand Six Hundred Eighty-Five (Php128,685.00)**, inclusive of applicable taxes to be the **Lowest Calculated and Responsive Quotation** to the requirements of PHILGUARANTEE (copy of the Memorandum dated January 31, 2022 is attached as Annex "A") and recommended to the BAC its award;

NOW THEREFORE, in consideration of the recommendation of the Human Resource and Organizational Development Department, the Bids and Awards Committee resolved to recommend the approval by the Head of the Procuring Entity of the following:

- a. The use of Small Value Procurement for the procurement of individually packed meals for PHILGUARANTEE's 45th founding anniversary celebration with an Approved Budget for the Contract (ABC) of **Pesos: One Hundred Thirty Thousand Five Hundred Fifty (Php130,550.00)**, inclusive of applicable taxes; and
- b. The award of contract to **Max's Kitchen, Inc.** for the procurement of individually packed meals for PHILGUARANTEE's 45th founding anniversary celebration in the amount of **Pesos: One Hundred Twenty-Eight Thousand Six Hundred Eighty-Five (Php128,685.00)**, inclusive of all applicable taxes.
