R E S O L U T I O N N O. 2022-017

WHEREAS, the Corporate Compliance and Standards Office (CCSO) requested the Bids and Awards Committee (BAC) for the procurement of services of a provider to conduct Documentation, Training, and Consultancy Services for the Recertification of the Integrated Management System (IMS) with an Approved Budget for the Contract (ABC) of **Pesos: Seven Hundred Thousand (Php700,000.00)**, inclusive of applicable taxes;

WHEREAS, CFA:002-2022 in the amount of **Pesos: Seven Hundred Thousand (Php700,000.00)**, was issued by the Budget Management Department (BMD) for this purpose;

WHEREAS, the requested procurement is under the approved Annual Procurement Plan (APP) for FY 2022-Supplemental 1, viz:

WHEREAS, in order to promote economy and efficiency, alternative methods of procurement may be resorted to in accordance with Section 48.1 of the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184 or the Government Procurement Reform Act, such as in this case;

WHEREAS, the item to be procured does not exceed the threshold prescribed in Section V.D.8.a.i of Annex H of the 2016 Revised IRR of RA No. 9184;

WHEREAS, Section V.D.8.b.ii of Annex H of the 2016 Revised IRR of RA No. 9184 provides that:

- “ii. BAC shall prepare and send the RFQs/RFPs to at least three (3) suppliers, contractors or consultants of known qualifications. This, notwithstanding, those who responded through any of the required postings shall be allowed to participate. Receipt of at least one (1) quotation is sufficient to proceed with the evaluation thereof.
- iii. Except for those with ABCs equal to Fifty Thousand Pesos (P50,000.00) and below, RFQs shall be posted for a period of three (3) calendar days in the PhilGEPS website, website of the Procuring Entity, if available, and at any conspicuous place reserved for this purpose in the premises of the Procuring Entity.”

WHEREAS, the Request for Proposal (RFP) was posted and sent on February 3, 2022 to the following service providers:

1. EIAN Management Consulting Services;
2. IMSM Philippines Corporation; and
3. Rosehall Management Consultants.

WHEREAS, the following service providers submitted proposals before the deadline of February 8, 2022; 2:00 P.M:

1. AJV Management Consultancy received on February 05, 2022, 6:53 P.M.;
2. MMP Management System Consultancy Services received on February 08, 2022, 11:15 A.M.;
3. EIAN Management Consulting Services received on February 08, 2022, 1:00 P.M.; and
4. Rosehall Management Consultants, Inc. received on February 08, 2022, 1:37 P.M.

WHEREAS, the CCSO determined that the proposal of **EIAN Management Consulting Services** in the amount of **Pesos: Six Hundred Seventy-Two Thousand (Php672,000.00)**, inclusive of applicable taxes to be the **Highest Rated and Responsive Proposal** to the requirements of PHILGUARANTEE (copy of the Memorandum dated February 10, 2022 is attached as Annex "A") and recommended to the BAC its award;

NOW THEREFORE, in consideration of the recommendation of the Corporate Compliance and Standards Office, the Bids and Awards Committee resolved to recommend the approval by the Head of the Procuring Entity of the following:

- a. The use of **Small Value Procurement** for the procurement of services of a provider to conduct Documentation, Training, and Consultancy Services for the Recertification of the Integrated Management System (IMS) with an Approved Budget for the Contract (ABC) of **Pesos: Seven Hundred Thousand (Php700,000.00)**, inclusive of applicable taxes; and
- b. The award of contract to **EIAN Management Consulting Services** for the procurement of services of a provider to conduct Documentation, Training, and Consultancy Services for the Recertification of the Integrated Management System (IMS) in the amount of **Pesos: Six Hundred Seventy-Two Thousand (Php672,000.00)**, inclusive of applicable taxes.
