R E S O L U T I O N N O. 2022-056

WHEREAS, the Corporate Compliance and Standards Office (CCSO) requested the Bids and Awards Committee (BAC) for the procurement of **Catering Services for In-House Training of IMS (ISO) Core Team** with an Approved Budget for the contract (ABC) of **Pesos: Ninety Thousand (Php90,000.00)**, inclusive of all applicable taxes;

WHEREAS, CFA:055-2022 in the amount of **Pesos: Ninety Thousand (Php90,000.00)** was issued by the Budget Management Department (BMD) for this purpose;

WHEREAS, the requested procurement is included in the Philippine Guarantee Corporation Annual Procurement Plan (APP) for FY 2022, viz:

Procurement Program/Project	Mode of Procurement	Estimated Budget (MOOE)
Catering Services	NP-53.9 - Small Value Procurement	Php500,000.00

WHEREAS, in order to promote economy and efficiency, alternative methods of procurement may be resorted to in accordance with Section 48.1 of the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184 or the Government Procurement Reform Act, such as in this case;

WHEREAS, the item to be procured does not exceed the threshold prescribed in Section V.D.8.a.i of Annex H of the 2016 Revised IRR of RA No. 9184;

WHEREAS, Section V.D.8.b.ii and iii of Annex H of the 2016 Revised IRR of RA No. 9184 provides that:

- “ii. BAC shall prepare and send the RFQs/RFPs to at least three (3) suppliers, contractors or consultants of known qualifications. This, notwithstanding, those who responded through any of the required postings shall be allowed to participate. Receipt of at least one (1) quotation is sufficient to proceed with the evaluation thereof.
- iii. Except for those with ABCs equal to Fifty Thousand Pesos (P50,000.00) and below, RFQs shall be posted for a period of three (3) calendar days in the PhilGEPS website, website of the Procuring Entity, if available, and at any conspicuous place reserved for this purpose in the premises of the Procuring Entity.”

WHEREAS, the Request for Quotation (RFQ) was posted and sent on April 13, 2022 to the following service providers:

1. Hizon's Catering and Services;
2. Max's Kitchen, Inc. - Jupiter Branch; and
3. Roxas Food Ventures, Inc.

WHEREAS, only Max's Kitchen, Inc. - Jupiter Branch submitted its quotation on April 16, 2022; 12:29 P.M. before the deadline of April 18, 2022; 2:00 P.M.;

WHEREAS, the CCSO determined that Max's Kitchen, Inc. - Jupiter Branch's quotation was not responsive with the requirements of the Corporation (copy of the Memorandum dated April 18, 2022 is herein attached as Annex "A") and recommended to the BAC a declaration of a failure of bidding;

WHEREAS, Section 35.1.c of the 2016 Revised Implementing Rules and Regulations of Republic Act No. 9184 provides that:

The BAC shall declare the bidding a failure when:

"All bids fail to comply with all the bid requirements or fail post-qualification, or, in the case of Consulting Services, there is no successful negotiation"

NOW THEREFORE, in consideration of the recommendation of the Corporate Compliance and Standards Office, the Bids and Awards Committee resolved to declare a failure of bidding for the procurement of **Catering Services for In-House Training of IMS (ISO) Core Team** with an Approved Budget for the contract (ABC) of **Pesos: Ninety Thousand (Php90,000.00)**, inclusive of all applicable taxes.
