**WHEREAS**, the Facilities and General Services Department (FGSD) requested the Bids and Awards Committee (BAC) for the **Procurement of Janitorial Services of PHILGUARANTEE for CY 2022-2023/PGC-BAC-2022-003G** with an **Approved Budget for the Contract of Pesos: Five Million One Hundred Eighty-One Thousand Ninety-Nine and 91/100 (PHP5,181,099.91)**, inclusive of all applicable taxes;

**WHEREAS**, **CFA: 014-2022** in the amount of **Pesos: Five Million One Hundred Eighty-One Thousand Ninety-Nine and 91/100 (PHP5,181,099.91)** was issued by the Budget Management Department for this purpose;

**WHEREAS**, the requested procurement is under the approved Philippine Guarantee Corporation Annual Procurement Plan (APP) for FY 2022 – Supplemental 1, viz:

**WHEREAS**, the Invitation to Bid was posted on the PHILGUARANTEE and PhilGEPS websites, and at PHILGUARANTEE-Jade office bulletin board on March 7, 2022;

**WHEREAS**, in response to the aforesaid invitation, the representatives from the following bidders attended the pre-bid conference on March 22, 2022:

1. CBII Philippines International, Inc.;
2. Excellent General Services, Inc.
3. Executive Genesis Services, Inc.;
4. Omniworx Inc.; and
5. Ultimate Care Janitorial and Allied Services.

**WHEREAS**, the following suppliers submitted their quotations before the deadline of April 4, 2022; 1:45 P.M.:

1. Omniworx Inc. received on April 4, 2022; 11:03 A.M.; and
2. Excellent General Services Inc. received on April 4, 2022; 11:58 A.M.

**WHEREAS**, during the opening of bids on April 4, 2022; 2:00 P.M., both **Omniworx Inc.** and **Excellent General Services Inc.** were determined to have "PASSED" the Technical Components (Eligibility and Technical Requirements) and Financial Components;

**WHEREAS, Omniworx Inc. and Excellent General Services Inc.’s** Financial Bid were read as follows:

**WHEREAS,** on April 11, 2022, based on the bid evaluation and recommendation made by the TWG, the BAC declared the financial bid of **Omniworx Inc.** in the amount of **PESOS: Five Million Eighty-Six Thousand One Hundred Thirteen and 45/100 (Php5,086,113.45)**, inclusive of all applicable taxes as the **Lowest Calculated Bid** and proceeded with its post-qualification;

**WHEREAS,** on April 25, 2022, upon verification, validation and ascertainment of the statements made and documents submitted by **Omniworx Inc.** the TWG determined that the bid of **Omniworx Inc.** responsive to all the criteria of the post-qualification (legal, technical and financial) and recommended the award of the contract;

**NOW, THEREFORE,** in consideration of the recommendation of the Technical Working Group, the Bids and Awards Committee (BAC), hereby **RESOLVE** the following:

- a) To declare the bid submission of **Omniworx Inc.** as the **Lowest Calculated and Responsive Bid** for the **Procurement of Janitorial Services of PHILGUARANTEE for CY 2022-2023/PGC-BAC-2022-003G**; and
- b) To recommend approval by the **Head of the Procuring Entity (HoPE)** the award of contract for the **Procurement of Janitorial Services of PHILGUARANTEE for CY 2022-2023/PGC-BAC-2022-003G** to **Omniworx Inc.** in the amount of **PESOS: Five Million Eighty-Six Thousand One Hundred Thirteen and 45/100 (Php5,086,113.45)**, inclusive of all applicable taxes.


