R E S O L U T I O N N O. 2021-243

WHEREAS, the Facilities and General Services Department (FGSD) requested the Bids and Awards Committee (BAC) for the procurement of Pest Control Services for the treatment of PHILGUARANTEE offices located at Jade Building (2nd to 5th floor) and 17th floor BDO Valero Tower with an Approved Budget for the Contract (ABC) of **Pesos: Two Hundred Thirty-One Thousand Five Hundred Sixty (Php231,560.00)**, inclusive of applicable taxes;

WHEREAS, CFA:192-2021 in the amount of **Pesos: Two Hundred Thirty-One Thousand Five Hundred Sixty (Php231,560.00)**, was issued by the Budget Management Department (BMD) for this purpose;

WHEREAS, the requested procurement is under the approved Philippine Guarantee Corporation Annual Procurement Plan (APP) for FY 2021, viz:

WHEREAS, in order to promote economy and efficiency, alternative methods of procurement may be resorted to in accordance with Section 48.1 of the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184 or the Government Procurement Reform Act, such as in this case;

WHEREAS, the item to be procured does not exceed the threshold prescribed in Section V.D.8.a.i of Annex H of the 2016 Revised IRR of RA No. 9184;

WHEREAS, Section V.D.8.b.ii and iii of Annex H of the 2016 Revised IRR of RA No. 9184 provides that:

“ii. BAC shall prepare and send the RFQs/RFPs to at least three (3) suppliers, contractors or consultants of known qualifications. This, notwithstanding, those who responded through any of the required postings shall be allowed to participate. Receipt of at least one (1) quotation is sufficient to proceed with the evaluation thereof.

iii. Except for those with ABCs equal to Fifty Thousand Pesos (P50,000.00) and below, RFQs shall be posted for a period of three (3) calendar days in the PhilGEPS website, website of the Procuring Entity, if available, and at any conspicuous place reserved for this purpose in the premises of the Procuring Entity.”

WHEREAS, the Request for Quotation (RFQ) was sent on November 18, 2021 to the following service providers:

1. FYN Disinfection Services;
2. Pest Science Corporation;
3. Pesticon Enterprises Inc.; and
4. Power House Pest Control Services.

WHEREAS, the Bid Bulletin 1 was posted on November 22, 2021;

WHEREAS, the following suppliers submitted quotations before the deadline of November 23, 2021; 2:00 P.M:

1. Power House Pest Control Services received on November 20, 2021, 4:42 P.M.;
2. FYN Disinfecting & Exterminating Services received on November 22, 2021, 8:00 A.M.;
3. D-Three Pest Management Services received on November 23, 2021, 8:43 A.M.;
4. MAC J Pest Control Services received on November 23, 2021, 1:00 P.M.; and
5. Pest Science Corporation received on November 23, 2021, 1:25 P.M.

WHEREAS, the FGSD determined that the proposal of **MAC J Pest Control Services** in the amount of **Pesos: One Hundred Fifty-Three Thousand Six Hundred (Php153,600.00)**, inclusive of applicable taxes to be the **Lowest Calculated and Responsive Quotation** to the requirements of PHILGUARANTEE (copy of the Memorandum dated November 26, 2021 is attached as Annex "A") and recommended to the BAC its award;

NOW THEREFORE, in consideration of the recommendation of the Facilities and General Services Department, the Bids and Awards Committee resolved to recommend the approval by the Head of the Procuring Entity of the following:

- a. The use of **Small Value Procurement** for the procurement of Pest Control Services for the treatment of PHILGUARANTEE offices located at Jade Building (2nd to 5th floor) and 17th floor BDO Valero Tower with an Approved Budget for the Contract (ABC) of **Pesos: Two Hundred Thirty-One Thousand Five Hundred Sixty (Php231,560.00)**, inclusive of applicable taxes; and
- b. The award of contract to **MAC J Pest Control Services** for the procurement of Pest Control Services for the treatment of PHILGUARANTEE offices located at Jade Building (2nd to 5th floor) and 17th floor BDO Valero Tower in the amount of **Pesos: One Hundred Fifty-Three Thousand Six Hundred (Php153,600.00)**, inclusive of applicable taxes.
