  - iii. Notice of Award of Contract; and the Bidder's conforme thereto; and
  - iv. Other related documents in relation to the bid. Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.
- In consideration for the sum of Pesos: Twenty-Four Thousand (Php24,000.00), inclusive of applicable taxes or such other sums as may be ascertained, Pro-Valuers Alliance Corporation agrees to Conduct an updated Appraisal of Two (2) Lots Located at Margarita Northville, Barangay Sapang Maragul, Tarlac City, Tarlac in accordance with his/her/its Bid.
- 4. The **PHILIPPINE GUARANTEE CORPORATION** agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.
