R E S O L U T I O N N O. 2022-020

WHEREAS, the Facilities and General Services Department (FGSD) requested the Bids and Awards Committee (BAC) for the procurement of Bond Paper Requirement for the First Quarter of 2022 with an Approved Budget for the Contract (ABC) of **Pesos: One Hundred Eight Thousand Nine Hundred Ten (Php108,910.00)**, inclusive of applicable taxes;

WHEREAS, CFA:020-2022 in the amount of **Pesos: One Hundred Eight Thousand Nine Hundred Ten (Php108,910.00)**, was issued by the Budget Management Department (BMD) for this purpose;

WHEREAS, the requested procurement is under the approved Philippine Guarantee Corporation Annual Procurement Plan (APP) for FY 2022, viz:

WHEREAS, in order to promote economy and efficiency, alternative methods of procurement may be resorted to in accordance with Section 48.1 of the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184 or the Government Procurement Reform Act, such as in this case;

WHEREAS, pursuant to Section V.C.1.b of Annex H of the 2016 Revised IRR of RA No. 9184, Shopping shall be employed for the procurement of ordinary or regular office supplies and equipment not available in the DBM-PS, in the amount not to exceed the One Million Pesos (₱1,000,000) for GOCCs;

WHEREAS, Section V.C.2.b.iii and iv of Annex H of the 2016 Revised IRR of RA No. 9184 provides that:

- “iii. Except for those with ABCs equal to Fifty Thousand Pesos (₱50,000.00) and below, RFQs shall be posted for a period of at least three (3) calendar days in the PhilGEPS website, website of the Procuring Entity, if available, and at any conspicuous place reserved for this purpose in the premises of the Procuring Entity.
- “iv. The BAC shall send the RFQs to at least three (3) suppliers of known qualifications, and at least three (3) price quotations must be obtained. This, notwithstanding, those who responded through any of the required postings shall be allowed to participate.”

WHEREAS, the Request for Quotation (RFQ) was posted and sent on February 8, 2022 to the following suppliers:

1. Banbee Commercial Co. Inc;
2. Clockwerk Stationery Trading;
3. Mostaco Marketing;
4. Propen Office Supplies and Equipment Trading; and
5. Triplex Enterprises.

WHEREAS, the following suppliers submitted quotations before the deadline of February 14, 2022; 2:00 P.M:

1. Ban Bee Commercial Co., Inc. received on February 09, 2022, 01:41 P.M.;
2. Mostaco Marketing received on February 10, 2022, 8:00 A.M.;
3. Triplex Enterprises Inc. received on February 11, 2022, 5:15 P.M.;
4. Purity Paper, Inc. received on February 14, 2022, 10:00 A.M.; and
5. Accessories and Supplies Depot Inc. received on February 14, 2022, 12:55 P.M.

WHEREAS, the FGSD determined that the quotation of **Triplex Enterprises, Inc.** in the amount of **Pesos: Ninety-Six Thousand Three Hundred Thirty (Php96,330.00)**, inclusive of applicable taxes to be the **Single Calculated and Responsive Quotation** to the requirements of PHILGUARANTEE (copy of the Memorandum dated February 17, 2022 is attached as Annex "A") and recommended to the BAC its award;

NOW THEREFORE, in consideration of the recommendation of the Facilities and General Services Department, the Bids and Awards Committee resolved to recommend the approval by the Head of the Procuring Entity of the following:


- a. The use of **Shopping** for the procurement of Bond Paper Requirement for the First Quarter of 2022 with an Approved Budget for the Contract (ABC) of **Pesos: One Hundred Eight Thousand Nine Hundred Ten (Php108,910.00)**, inclusive of applicable taxes; and
- b. The award of contract to **Triplex Enterprises, Inc.** for the procurement of Bond Paper Requirement for the First Quarter of 2022 in the amount of **Pesos: Ninety-Six Thousand Three Hundred Thirty (Php96,330.00)**, inclusive of all applicable taxes.
