

CONTRACT AGREEMENT

31 JAN 2022


THIS AGREEMENT made the _____ day of January 2022 between **PHILIPPINE GUARANTEE CORPORATION** of the Philippines (hereinafter called "the Entity") of the one part and **MAX'S KITCHEN, INC.** of 2212 Chino Roces Avenue, Barangay Pio Del Pilar, Makati City, Philippines (hereinafter called "the Supplier") of the other part;

WHEREAS, the Entity invited Bids for certain goods and ancillary services, particularly the "**PROCUREMENT OF INDIVIDUALLY PACKED MEALS FOR PHILGUARANTEE'S 45TH FOUNDING ANNIVERSARY CELEBRATION**" and has accepted a Bid by the Supplier for the supply of those goods and services in the sum of **Pesos: One Hundred Twenty-Eight Thousand Six Hundred Eighty-Five (Php128,685.00)**, inclusive of applicable taxes (hereinafter called "the Contract Price").

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement words and expressions shall have the same meanings as respectively assigned to them in the Conditions of Contract referred to.
2. The following documents as required by the 2016 revised Implementing Rules and Regulations of Republic Act No. 9184 shall be deemed to form and be read and construed as integral part of this Agreement, viz.:
 - i. Terms of Reference;
 - ii. Request for Quotation;
 - ii. Winning bidder's proposal;
 - iii. Notice of Award of Contract; and the Bidder's conforme thereto; and
 - iv. Other related documents in relation to the bid. Winning bidder agrees to additional contract documents or information prescribed by the GPP that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Order, and Warranty Security, shall likewise form part of the Contract.
3. In consideration for the sum of **Pesos: One Hundred Twenty-Eight Thousand Six Hundred Eighty-Five (Php128,685.00)**, inclusive of applicable taxes or such other sums as may be ascertained, **MAX'S KITCHEN, INC.** agrees to **supply and deliver individually packed meals for PHILGUARANTEE's 45th founding anniversary celebration** in accordance with his/her/its Bid.
4. The **PHILIPPINE GUARANTEE CORPORATION** agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.
