R E S O L U T I O N N O. 2022-052

WHEREAS, the Facilities and General Services Department (FGSD) requested the Bids and Awards Committee (BAC) for the procurement of services for the **Replacement of the Control Panel for Cooling Water Pump Servicing Two (2) Units of Water-Cooled Air Conditioning Unit (ACU) at BDO Towers Office Server Room** with an Approved Budget for the Contract (ABC) of **Pesos: Fifty-Six Thousand Seven Hundred Fifty (Php56,750.00)**, inclusive of applicable taxes;

WHEREAS, CFA:051-2022 in the amount of **Pesos: Fifty-Six Thousand Seven Hundred Fifty (Php56,750.00)**, was issued by the Budget Management Department (BMD) for this purpose;

WHEREAS, the requested procurement is included in the Philippine Guarantee Corporation Annual Procurement Plan (APP) for FY 2022, viz:

WHEREAS, in order to promote economy and efficiency, alternative methods of procurement may be resorted to in accordance with Section 48.1 of the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184 or the Government Procurement Reform Act, such as in this case;

WHEREAS, the item to be procured does not exceed the threshold prescribed in Section V.D.8.a.i of Annex H of the 2016 Revised IRR of RA No. 9184;

WHEREAS, Section V.D.8.b.ii and iii of Annex H of the 2016 Revised IRR of RA No. 9184 provides that:

- “ii. BAC shall prepare and send the RFQs/RFPs to at least three (3) suppliers, contractors or consultants of known qualifications. This, notwithstanding, those who responded through any of the required postings shall be allowed to participate. Receipt of at least one (1) quotation is sufficient to proceed with the evaluation thereof.

- iii. Except for those with ABCs equal to Fifty Thousand Pesos (₱50,000.00) and below, RFQs shall be posted for a period of three (3) calendar days in the PhilGEPS website, website of the Procuring Entity, if available, and at any conspicuous place reserved for this purpose in the premises of the Procuring Entity.”

WHEREAS, the Request for Quotation (RFQ) was posted and sent on April 5, 2022 to the following service providers:

1. Alvhea Trading;
2. Emmars Air Conditioning Services; and
3. Sun Valley Multipurpose Cooperative.

WHEREAS, only Sun Valley Multipurpose Cooperative submitted its quotation on April 7, 2022; 2:38 P.M. before the deadline of April 8, 2022; 2:00 P.M.;

WHEREAS, the FGSD determined that the quotation of Sun Valley Multipurpose Cooperative was not responsive with the requirements of PHILGUARANTEE (Memorandum dated April 11, 2022 attached as Annex A) and recommended for the declaration of a failure of bidding and reposting of the Request for Quotation;

WHEREAS, Section 35.1.c of the 2016 Revised Implementing Rules and Regulations of Republic Act No. 9184 provides that:

The BAC shall declare the bidding a failure when:

“All bids fail to comply with all the bid requirements or fail post-qualification, or, in the case of Consulting Services, there is no successful negotiation”

NOW THEREFORE, in consideration of the recommendation of the Facilities and General Services Department, the Bids and Awards Committee resolved the following:


- a. To declare a failure of bidding for the procurement of services for the **Replacement of the Control Panel for Cooling Water Pump Servicing Two (2) Units of Water-Cooled Air Conditioning Unit (ACU) at BDO Towers Office Server Room** with an Approved Budget for the Contract (ABC) of **Pesos: Fifty-Six Thousand Seven Hundred Fifty (Php56,750.00)**, inclusive of applicable taxes; and
- b. To repost (2nd posting) the Request for Quotation for the procurement of services for the **Replacement of the Control Panel for Cooling Water Pump Servicing Two (2) Units of Water-Cooled Air Conditioning Unit (ACU) at BDO Towers Office Server Room** with an Approved Budget for the Contract (ABC) of **Pesos: Fifty-Six Thousand Seven Hundred Fifty (Php56,750.00)**, inclusive of applicable taxes.
