WHEREAS, Philcopy Corporation submitted its quotation on April 8, 2022 at 4:05 P.M. before the deadline of April 12, 2022; 2:00 P.M. in the amount Pesos: Eight Hundred Fifty-Eight Thousand Six Hundred Twenty-Five (Php858,625.00), inclusive of applicable taxes;

WHEREAS, the FGSD recommended the Award of contract to Philcopy Corporation (copy of the memorandum dated April 13, 2022 herein attached as Annex A);

NOW THEREFORE, in consideration of the recommendation of the Facilities and General Services Department, the Bids and Awards Committee resolved to recommend the approval by the Head of the Procuring Entity of the following:

The use of Alternative Mode of Procurement-Direct Contracting for the procurement of Toner Cartridges for Kyocera Printers for the Second Quarter of CY 2022 with an Approved Budget for the Contract (ABC) of Pesos: Eight Hundred Fifty-Eight Thousand Six Hundred Twenty-Five (Php858,625.00), inclusive of applicable taxes; and
