**R E S O L U T I O N N O . 2 0 2 2 - 0 8 4**

**WHEREAS**, the Human Resource and Organizational Development Department (HRODD) in its Memorandum dated March 15, 2022 (copy as Annex A), requested the Bids and Awards Committee (BAC) for the procurement of **COVID Home Care Kits** with an Approved Budget for the Contract (ABC) of **Pesos: One Hundred Fifty-Four Thousand One Hundred Seventy-Two (Php154,172.00)**, inclusive of applicable taxes;

**WHEREAS**, pursuant to BAC Resolution 2022-057 (copy attached as Annex B), the Bids and Awards Committee recommended to the Head of the Procuring Entity the award of contract to **Ryrah Merchandising** for the procurement of **COVID Home Care Kits** in the amount of **Pesos: One Hundred Thousand (Php100,000.00)**, inclusive of all applicable taxes;

**WHEREAS**, pursuant to HRODD'S Memorandum dated May 13, 2022 (copy attached as Annex C), the Officer-In-Charge approved the cancellation of the said procurement due to the declining cases of COVID-19 infections in the country and zero incidence of COVID-19 infection in PHILGUARANTEE since February 7, 2022;

**WHEREAS**, Section 41.c. Reservation Clause of the 2016 revised IRR of RA 9184 provides that:

“The HoPE reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract in the following situations:

For any justifiable and reasonable ground where the award of the contract will not redound to the benefit of the GoP, as follows: (i) if the physical and economic conditions have significantly changed so as to render the project no longer economically, financially, or technically feasible, as determined by the HoPE; (ii) if the project is no longer necessary as determined by the HoPE; or XXX.”

**NOW THEREFORE**, having considered the foregoing circumstances, the Bids and Awards Committee resolved to note the approval by the Officer-In-Charge/Head of the Procuring Entity on the cancellation of the procurement of **COVID Home Care Kits** with an Approved Budget for the Contract (ABC) of **Pesos: One Hundred Fifty-Four Thousand One Hundred Seventy-Two (Php154,172.00)**, inclusive of applicable taxes.
