R E S O L U T I O N N O. 2022-096

WHEREAS, the Facilities and General Services Department (FGSD) requested the Bids and Awards Committee (BAC) for the procurement of **Various Grocery Items for the Second Quarter of 2022** with an Approved Budget for the contract (ABC) of **Pesos: One Hundred Twenty Thousand Four Hundred Forty-Eight and 72/100 (Php120,448.72)**, inclusive of all applicable taxes;

WHEREAS, CFA:084-2022 in the amount of **Pesos: One Hundred Twenty Thousand Four Hundred Forty-Eight and 72/100 (Php120,448.72)**, was issued by the Budget Management Department (BMD) for this purpose;

WHEREAS, the requested procurement is under the approved Philippine Guarantee Corporation Annual Procurement Plan (APP) for FY 2022, viz:

WHEREAS, in order to promote economy and efficiency, alternative methods of procurement may be resorted to in accordance with Section 48.1 of the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184 or the Government Procurement Reform Act, such as in this case;

WHEREAS, pursuant to Section V.C.1.b of Annex H of the 2016 Revised IRR of RA No. 9184, Shopping shall be employed for the procurement of ordinary or regular office supplies and equipment not available in the DBM-PS, in the amount not to exceed the One Million Pesos (₱1,000,000) for GOCCs;

WHEREAS, Section V.C.2.b.iii and iv of Annex H of the 2016 Revised IRR of RA No. 9184 provides that:

- “iii. Except for those with ABCs equal to Fifty Thousand Pesos (₱50,000.00) and below, RFQs shall be posted for a period of at least three (3) calendar days in the PhilGEPS website, website of the Procuring Entity, if available, and at any conspicuous place reserved for this purpose in the premises of the Procuring Entity.

- iv. The BAC shall send the RFQs to at least three (3) suppliers of known qualifications, and at least three (3) price quotations must be obtained. This, notwithstanding, those who responded through any of the required postings shall be allowed to participate.”

WHEREAS, the Request for Quotation (RFQ) was posted and sent to the following suppliers on May 20, 2022:

1. Allday Supermarket;
2. Dynadvance Trading & Distribution (DTDl) Inc.;
3. Propen Trading Equipment and Office Supplies;
4. Puregold Price Club Inc. (Makati Branch); and
5. Walter Mart Supermarket Inc. (Sucat Branch).

WHEREAS, the following suppliers submitted quotations before the deadline of May 26, 2022; 10:00 A.M:

1. Ban Bee Commercial Co., Inc. received on May 26, 2022, 9:23 A.M.;
2. Waltermart Supermarket Inc. (Sucat Branch), received on May 26, 2022, 9:45 A.M.; and
3. Primetek International Non-Specialized Wholesale Trading received on May 26, 2022, 10:00 A.M.

WHEREAS, the FGSD determined that the proposal of **Waltermart Supermarket Inc. (Sucat Branch)** in the amount of **Pesos: One Hundred Eighteen Thousand Seven Hundred Twenty-Three (Php118,723.00)**, inclusive of applicable taxes to be the **Single Calculated and Responsive Quotation** to the requirements of PHILGUARANTEE (copy of the Memorandum dated May 30, 2022 is attached as Annex "A") and recommended to the BAC its award;

NOW THEREFORE, in consideration of the recommendation of the Facilities and General Services Department, the Bids and Awards Committee resolved to recommend the approval by the Head of the Procuring Entity of the following:


- a. The use of **Shopping** for the procurement of **Various Grocery Items for the Second Quarter of 2022** with an Approved Budget for the contract (ABC) of **Pesos: One Hundred Twenty Thousand Four Hundred Forty-Eight and 72/100 (Php120,448.72)**, inclusive of all applicable taxes; and
- b. The award of contract to **Waltermart Supermarket Inc. (Sucat Branch)** for the procurement of **Various Grocery Items for the Second Quarter of 2022** in the amount of **Pesos: One Hundred Eighteen Thousand Seven Hundred Twenty-Three (Php118,723.00)**, inclusive of applicable taxes.
