WHEREAS, the Housing Accounts Services Department (HASD) requested the Bids and Awards Committee (BAC) for the procurement of the following **Appliances**:

WHEREAS, CFA:063-2022 in the amount of **Pesos: Seventy-Four Thousand Five Hundred (Php74,500.00)**, was issued by the Budget Management Department (BMD) for this purpose;

WHEREAS, the requested procurement is included in the Philippine Guarantee Corporation Annual Procurement Plan (APP) for FY 2022 - Updated as of June 30, 2022, viz:

WHEREAS, in order to promote economy and efficiency, alternative methods of procurement may be resorted to in accordance with Section 48.1 of the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184 or the Government Procurement Reform Act, such as in this case;

WHEREAS, the item to be procured does not exceed the threshold prescribed in Section V.D.8.a.i of Annex H of the 2016 Revised IRR of RA No. 9184;

WHEREAS, Section V.D.8.b.ii and iii of Annex H of the 2016 Revised IRR of RA No. 9184 provides that:

- “ii. BAC shall prepare and send the RFQs/RFPs to at least three (3) suppliers, contractors or consultants of known qualifications. This, notwithstanding, those who responded through any of the required postings shall be allowed to participate. Receipt of at least one (1) quotation is sufficient to proceed with the evaluation thereof.
- iii. Except for those with ABCs equal to Fifty Thousand Pesos (P50,000.00) and below, RFQs shall be posted for a period of three (3) calendar days in the PhilGEPS website, website of the Procuring Entity, if available, and at any conspicuous place reserved for this purpose in the premises of the Procuring Entity.”

WHEREAS, the Request for Quotation (RFQ) was sent on July 8, 2022 to the following service providers:

1. Abenson Ventures Inc. - Cainta;
2. Anson Emporium Corporation; and
3. Western Appliances.

WHEREAS, only Japhet Unli-Sales Trading Co. submitted its quotation on July 8, 2022; 4:58 P.M. before the deadline of July 12, 2022; 10:00 A.M.;

WHEREAS, the HASD determined that the quotation submitted by Japhet Unli-Sales Trading Co. was not responsive with the requirements of PHILGUARANTEE (Memorandum dated July 13, 2022 attached as Annex A) and requested for the declaration of a failure of bidding;

WHEREAS, Section 35.1 a) of the 2016 Revised Implementing Rules and Regulations of Republic Act No. 9184 provides that:

The BAC shall declare the bidding a failure when:

“All bids fail to comply with all the bid requirements or fail post-qualification, or, in the case of Consulting Services, there is no successful negotiation”

NOW THEREFORE, in consideration of the recommendation of the Housing Accounts Services Department, the Bids and Awards Committee resolved to declare a failure of bidding for the procurement of the following **Appliances**:
