

CONTRACT AGREEMENT

THIS AGREEMENT, made this _____ day of August, 2022 between **PHILIPPINE GUARANTEE CORPORATION** of the Philippines (hereinafter called the "Entity") and **JOCELYN C. LINSAO-NG** of No. 1 Pisces Street, T. S. Cruzville Subdivision, Zabarate Road, Barangay Kaligayahan, Novaliches, Quezon City, Philippines (hereinafter called the "Consultant").

1. In this Agreement, words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract hereinafter referred to.
2. The following documents shall be attached, deemed to form, and be read and construed as part of this Agreement, to wit:
 - (a) Terms of Reference;
 - (b) Winning bidder's proposal;
 - (c) Notice of Award of Contract and the Bidder's conforme thereto; and
 - (d) Other related documents in relation to the bid. **Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, shall likewise form part of the Contract.**
3. In consideration of the payments to be made by the Entity to the Consultant as hereinafter mentioned, the Consultant hereby covenants with the Entity to execute and complete the Consulting Services and remedy any defects therein in conformity with the provisions of this Consultant in all respects.
4. The Entity hereby covenants to pay the Consultant in consideration of the execution and completion of the Consulting Services, the Contract Price or such other sum as may become payable under the provisions of this Contract at the times and in the manner prescribed by this Contract.
