

CONTRACT AGREEMENT

THIS AGREEMENT made this ____ day of July 2022 between **PHILIPPINE GUARANTEE CORPORATION** of the Philippines (hereinafter called "the Entity") of the one part and **LSERV CORPORATION** of 21F Petron Megaplaza Building, 358 Senator Gil J. Puyat Avenue, Makati City, Philippines (hereinafter called "the Supplier") of the other part;

WHEREAS, the Entity invited Bids for certain goods and ancillary services, particularly the "**PROCUREMENT OF MANPOWER SERVICES FOR CY 2022/PGC-BAC-2022-007G**" and has accepted a Bid by the Supplier for the supply of those goods and services in the sum of **Pesos: Sixty-Three Million Eight Hundred Eighty-Six Thousand Three Hundred Seventeen and 96/100 (Php63,886,317.96)**, inclusive of applicable taxes (hereinafter called "the Contract Price").

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.
2. The following documents as required by the 2016 revised Implementing Rules and Regulations of Republic Act No. 9184 shall be deemed to form and be read and construed as integral part of this Agreement, viz.:
 - i. Philippine Bidding Documents (PBDs)
 - i. Invitation to Bid;
 - ii. Instruction to Bidders;
 - iii. Bid Data Sheet;
 - iv. General and Special Conditions of Contract;
 - v. Schedule of Requirements;
 - vi. Technical Specifications;
 - vii. Terms of Reference; and
 - viii. Supplemental or Bid Bulletin, if any.
 - ii. Winning bidder's bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted; Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;
 - iii. Performance Security;
 - iv. Notice of Award of Contract; and the Bidder's conforme thereto; and
 - v. Other related documents in relation to the bid. **Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.**
3. In consideration for the sum of **Pesos: Sixty-Three Million Eight Hundred Eighty-Six Thousand Three Hundred Seventeen and 96/100 (Php63,886,317.96)**,
