R E S O L U T I O N N O. 2022-160

WHEREAS, the Information Technology Department (ITD) requested the Bids and Awards Committee (BAC) for the procurement of **Financial Information System (FIS) – Enterprise Resource Planning System License Support** with an Approved Budget for the Contract (ABC) of **Pesos: Nine Hundred Ninety Thousand (Php990,000.00)**, inclusive of applicable taxes;

WHEREAS, CFA:126-2022 in the amount of **Pesos: Nine Hundred Ninety Thousand (Php990,000.00)**, was issued by the Budget Management Department (BMD) for this purpose;

WHEREAS, the requested procurement is included in the Philippine Guarantee Corporation Annual Procurement Plan (APP) for FY 2022 – Updated as of June 30, 2022, viz:

Procurement Program/Project	Mode of Procurement	Estimated Budget (MOOE)
Enterprise Resource Planning System License Support	NP-53.9 - Small Value Procurement	Php990,000.00

WHEREAS, in order to promote economy and efficiency, alternative methods of procurement may be resorted to in accordance with Section 48.1 of the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184 or the Government Procurement Reform Act, such as in this case;

WHEREAS, the item to be procured does not exceed the threshold prescribed in Section V.D.8.a.i of Annex H of the 2016 Revised IRR of RA No. 9184;

WHEREAS, Section V.D.8.b.ii and iii of Annex H of the 2016 Revised IRR of RA No. 9184 provides that:

- “ii. BAC shall prepare and send the RFQs/RFPs to at least three (3) suppliers, contractors or consultants of known qualifications. This, notwithstanding, those who responded through any of the required postings shall be allowed to participate. Receipt of at least one (1) quotation is sufficient to proceed with the evaluation thereof.
- iii. Except for those with ABCs equal to Fifty Thousand Pesos (P50,000.00) and below, RFQs shall be posted for a period of three (3) calendar days in the PhilGEPS website, website of the Procuring Entity, if available, and at any conspicuous place reserved for this purpose in the premises of the Procuring Entity.”

WHEREAS, the Request for Quotation (RFQ) were posted and sent on August 9, 2022 to the following service providers:

1. IOM Philippines, Inc.;
2. Oracle Corporation; and
3. SMS Global Technologies Inc.

WHEREAS, no quotation was received on or before the deadline of August 15 2022; 10:00 A.M.;

WHEREAS, the ITD in its Memorandum dated August 31, 2022 requested for the declaration of a failure of bidding because no bidder submitted a quotation before the deadline of August 15 2022; 10:00 A.M.;

WHEREAS, Section 35.1.c of the 2016 Revised Implementing Rules and Regulations of Republic Act No. 9184 provides that:

The BAC shall declare the bidding a failure when:

“No bids are received”

NOW THEREFORE, in consideration of the recommendation of the Information Technology Department, the Bids and Awards Committee resolved the following:

- a. To declare a failure of bidding for the procurement of **Financial Information System (FIS) – Enterprise Resource Planning System License Support** with an Approved Budget for the Contract (ABC) of **Pesos: Nine Hundred Ninety Thousand (Php990,000.00)**, inclusive of applicable taxes; and
- b. To repost (2nd posting) the Request for Quotation for the procurement of **Financial Information System (FIS) – Enterprise Resource Planning System License Support** with an Approved Budget for the Contract (ABC) of **Pesos: Nine Hundred Ninety Thousand (Php990,000.00)**, inclusive of applicable taxes.
