R E S O L U T I O N N O. 2022-162

WHEREAS, the Enterprise Risk and Management Office (ERMO) in its Memorandum dated August 31, 2022 (copy as Annex A), requested the Bids and Awards Committee (BAC) for the **Procurement of Consulting Services for the Development of Business Continuity Management System (BCMS)** with an Approved Budget for the Contract (ABC) of **Pesos: One Million Four Hundred Forty Thousand (Php1,440,000.00)**, inclusive of applicable taxes;

WHEREAS, the Request for Expression of Interest (REI) and the Philippine Bidding Documents (PBD) were posted on PHILGUARANTEE and PhilGEPS websites on September 23, 2022, as well as on PHILGUARANTEE's conspicuous place allotted for posting;

WHEREAS, in response to the said REI, only EIAN Management Consulting Services (EIAN) submitted its Eligibility Documents on September 30, 2022; 9:48 A.M. before the deadline of September 30, 2022, 1:15 P.M.;

WHEREAS, on September 30, 2022, during the opening and preliminary examination of the eligibility documents, it was determined that EIAN failed to submit the required format of the Eligibility Documents Submission Form as prescribed in the Public Bidding Documents and the required PhilGEPS Certificate of Registration and Membership in accordance with Section 8.5.2 of the IRR;

WHEREAS, the last paragraph of the Eligibility Documents Submission Form provides that:

“We further acknowledge that failure to sign this Eligibility Document Submission Form shall be a ground for our disqualification.”

WHEREAS, Clause 8.4 of Section II. Eligibility Documents provides that:

“XXX. If a prospective bidder is rated “failed” in any of the eligibility requirements, he shall be considered ineligible to participate in the bidding, and the BAC shall mark the set of eligibility documents of the prospective bidder concerned as “ineligible.” XXX”

WHEREAS, Section 35.1.b Failure of Bidding of the 2016 revised IRR of RA 9184 provides that:

The BAC shall declare the bidding a failure when:

“All prospective bidders are declared ineligible.”

NOW THEREFORE, having considered the foregoing circumstances, the Bids and Awards Committee resolved the following:

- a. To declare **EIAN Management Consulting Services** disqualified due to its failure to submit the required format of the Eligibility Documents Submission Form as prescribed in the Public Bidding Documents;
- b. To declared **EIAN Management Consulting Services** ineligible for its failure to submit the required PhilGEPS Certificate of Registration and Membership in accordance with Section 8.5.2 of the IRR; and
- c. To declare a failure of bidding for the **Procurement of Consulting Services for the Development of the Business Continuity Management System.**
