**RESOLUTION NO. 2022-172**

**WHEREAS**, the Enterprise Risk and Management Office, requested the Bids and Awards Committee for the rebidding of the **Procurement of Consulting Services for the Development of Business Continuity Management System (BCMS)** with an Approved Budget for the Contract (ABC) of **Pesos: One Million Four Hundred Forty Thousand (Php1,440,000.00), inclusive of applicable taxes;**

**WHEREAS**, the Request for Expression of Interest (REI) for the Procurement of Consulting Services for the Development of Business Continuity Management System (BCMS)/PGC-BAC-2022-003C were posted on the PhilGEPS and PHILGUARANTEE websites and PHILGUARANTEE's bulletin board on October 6, 2022;

**WHEREAS**, in response to the aforesaid REI, the following bidders submitted their eligibility bids before the deadline on October 13, 2022; 1:45 P.M.:

1. Haraya Consulting Co. (Haraya) received on October 13, 2022; 11:23 A.M.; and
2. EIAN Management Consulting Services (EIAN) received on October 13, 2022; 12:43 P.M.

**WHEREAS**, on October 13, 2022, during the opening and preliminary examination of eligibility documents using a non-discretionary "pass/fail" criterion, the BAC declared the following:

- a. EIAN is ineligible for its failure to submit the required PhilGEPS Certificate of Registration and Membership in accordance with Section 8.5.2 of the IRR; and
- b. Haraya is eligible since it was rated passed on all required eligibility documents, subject to further evaluation and shortlisting.

**WHEREAS**, shortlisting was scheduled on October 18, 2022; 1:30 P.M via video conferencing;

**WHEREAS**, on October 18, 2022, the TWG determined Haraya's total score of 70% did not pass the minimum score of 80%, details of which are as follows:

<b>Criteria</b>	<b>Weight</b>	<b>Haraya Consulting Co.</b>
i. Applicable experience of the consultant/firm and members in case of joint ventures	50%	20%
ii. Qualification of personnel who may be assigned to the job vis-à-vis extent and complexity of the undertaking	30%	30%
iii. Current work load relative to capacity	20%	20%
<b>TOTAL</b>	<b>100%</b>	<b>70%</b>

**WHEREAS**, since there was no consultant who passed the shortlisting, the TWG recommended the declaration of a failure of bidding;

**WHEREAS**, Section 35.1.c of the 2016 Revised Implementing Rules and Regulations of Republic Act No. 9184 provides that:

The BAC shall declare the bidding a failure when:

“All bids fail to comply with all the bid requirements or fail post-qualification, or, in the case of Consulting Services, there is no successful negotiation.”

**WHEREAS**, GPM Volume 4, Manual and Procedures for Consulting Services provides that:

“If no eligible bidder is short listed, the BAC shall declare a failure of bidding and issue a Resolution declaring the same. XXX

Should a second failure of bidding occur, the BAC shall again review and, as necessary, revise the TOR, contract terms and conditions, evaluation criteria, ABC, and/or other provisions in the bidding documents. XXX”

**NOW, THEREFORE**, having considered the foregoing circumstances, the Bids and Awards Committee hereby **RESOLVES the following**:

- a. To declare as failure of bidding for the rebidding of the **Procurement of Consulting Services for the Development of Business Continuity Management System (BCMS)** with an Approved Budget for the Contract (ABC) of **Pesos: One Million Four Hundred Forty Thousand (Php1,440,000.00), inclusive of applicable taxes; and**
- b. The end-user and the TWG shall conduct a mandatory review of the Terms of Reference, contract terms and conditions, evaluation criteria, ABC, and/or other provisions in the bidding documents.




