WHEREAS, the Corporate Communications Department (CCD) requested the Bids and Awards Committee (BAC) for the procurement of the following items:

WHEREAS, CFA: 152-2022 in the amount of **Pesos: Four Hundred Ten Thousand (Php410,000.00)**, was issued by the Budget Management Department (BMD) for this purpose;

WHEREAS, the requested procurement is included in the Philippine Guarantee Corporation Annual Procurement Plan (APP) for FY 2022 – Supplemental 8, viz:

WHEREAS, in order to promote economy and efficiency, alternative methods of procurement may be resorted to in accordance with Section 48.1 of the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184 or the Government Procurement Reform Act, such as in this case;

WHEREAS, the item to be procured does not exceed the threshold prescribed in Section V.D.8.a.i of Annex H of the 2016 Revised IRR of RA No. 9184;

WHEREAS, Section V.D.8.b.ii and iii of Annex H of the 2016 Revised IRR of RA No. 9184 provides that:

- “ii. BAC shall prepare and send the RFQs/RFPs to at least three (3) suppliers, contractors or consultants of known qualifications. This, notwithstanding, those who responded through any of the required postings shall be allowed to participate. Receipt of at least one (1) quotation is sufficient to proceed with the evaluation thereof.
- iii. Except for those with ABCs equal to Fifty Thousand Pesos (P50,000.00) and below, RFQs shall be posted for a period of three (3) calendar days in the PhilGEPS website, website of the Procuring Entity, if available, and at any conspicuous place reserved for this purpose in the premises of the Procuring Entity.”

WHEREAS, the Requests for Quotations (3rd Posting) were posted and sent on November 11, 2022 to the following suppliers:

1. Avid Sales Corporation;
2. Henry's Professional Photo Marketing Inc.;
3. Infomax Enterprise;
4. J1tek Trading Corporation;
5. Macy's Camera Shop;
6. Metos Offshore, Inc.; and
7. St. Christ International Trading Corporation (Juan Claro Joven).

WHEREAS, the following suppliers submitted quotations before the deadline of November 15, 2022; 10:00 A.M:

1. Infomax Enterprise received on November 11, 2022;04:39 P.M. (Lot 1 to 13); and
2. St. Chris International Trading Corporation received on November 15, 2022; 9:10 A.M. (Lot 1 and 2);

WHEREAS, the CCD in its Memorandum dated November 21, 2022 determined that all quotations were not responsive to the requirements of the Corporation and requested for the declaration of a failure of bidding;

WHEREAS, Section 35.1 (c) of the 2016 Revised Implementing Rules and Regulations of Republic Act No. 9184 provides that:

The BAC shall declare the bidding a failure when:

“All bids fail to comply with all the bid requirements or fail post-qualification, or, in the case of Consulting Services, there is no successful negotiation”

WHEREAS, the CCD in the said memorandum also manifested that the mandatory review /revision was made and requested for the posting of the new Request for Quotation;

WHEREAS, Section IV.K of Annex H (Consolidated Guidelines for the Alternative Methods of Procurement) of the 2016 Revised Implementing Rules and Regulations of Republic Act No. 9184 which provides that:

“Mandatory Review. The BAC shall conduct a mandatory review and evaluation of the terms, conditions, specifications, cost estimates in the RFQ or RFP, if none or less than the required number of quotations or proposals are received, despite the extension of deadline for the third time.

Based on its findings, the BAC may revise the terms and conditions and specifications, and if necessary, adjust the ABC, subject to the required approvals, and repeat the procurement process.”

NOW THEREFORE, in consideration of the recommendation of the Corporate Communications Department, the Bids and Awards Committee resolved the following:

- a. To declare a failure of bidding for the third posting of the Request for Quotation and Terms of Reference for procurement of the following items:
