

CONTRACT AGREEMENT

THIS AGREEMENT made the ____ day of December 2022 between **PHILIPPINE GUARANTEE CORPORATION** of the Philippines (hereinafter called "the Entity") of the one part and **PEOPLE DYNAMICS, INC.** of 502 OMM Citra Building, 39 San Miguel Avenue, Ortigas Center, Pasig City, Philippines (hereinafter called "the Supplier") of the other part;


WHEREAS, the Entity invited Bids for certain goods and ancillary services, particularly the "**PROCUREMENT OF SERVICES OF A PROVIDER TO CONDUCT PRE-EMPLOYMENT AND PROMOTIONAL TEST**" and has accepted a Bid by the Supplier for the supply of those goods and services in the sum of **Pesos: Three Hundred Eighty-Five Thousand Eight Hundred Forty and 95/100 (Php385,840.95)**, inclusive of applicable taxes (hereinafter called "the Contract Price").

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.
2. The following documents as required by the 2016 revised Implementing Rules and Regulations of Republic Act No. 9184 shall be deemed to form and be read and construed as integral part of this Agreement, viz.:
 - i. Terms of Reference;
 - ii. Request for Quotation;
 - iii. Bid Bulletin No. 1;
 - iv. Winning bidder's proposal;
 - v. Notice of Award of Contract; and the Bidder's conforme thereto; and
 - vi. Other related documents in relation to the bid. Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.
3. In consideration for the sum of **Pesos: Three Hundred Eighty-Five Thousand Eight Hundred Forty and 95/100 (Php385,840.95)**, inclusive of applicable taxes or such other sums as may be ascertained, and **PEOPLE DYNAMICS, INC.** agrees to supply **SERVICES OF A PROVIDER TO CONDUCT PRE-EMPLOYMENT AND PROMOTIONAL TEST** in accordance with his/her/its Bid.
4. The **PHILIPPINE GUARANTEE CORPORATION** agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.




