**R E S O L U T I O N N O. 2022-218**

**WHEREAS**, the GAD Focal Point System (GFPS) - TWG requested the Bids and Awards Committee (BAC) for the procurement of **Services of a Training Provider for the Conduct of Anti-Violence Against Women Seminar for its Personnel** with an Approved Budget for the Contract (ABC) of **Pesos: Two Hundred Ten Thousand (Php210,000.00)**, inclusive of applicable taxes;

**WHEREAS**, CFA:195-2022 in the amount of **Pesos: Four Hundred Eighty-Six Thousand Four Hundred Seventy (Php486,470.00)**, was issued by the Budget Management Department (BMD) for this purpose;

**WHEREAS**, the requested procurement is included in the Philippine Guarantee Corporation Annual Procurement Plan (APP) for FY 2022 – Updated as of June 30, 2022, viz:

**WHEREAS**, in order to promote economy and efficiency, alternative methods of procurement may be resorted to in accordance with Section 48.1 of the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184 or the Government Procurement Reform Act, such as in this case;

**WHEREAS**, the item to be procured does not exceed the threshold prescribed in Section V.D.8.a.i of Annex H of the 2016 Revised IRR of RA No. 9184;

**WHEREAS**, Section V.D.8.b.ii and iii of Annex H of the 2016 Revised IRR of RA No. 9184 provides that:

- “ii. BAC shall prepare and send the RFQs/RFPs to at least three (3) suppliers, contractors or consultants of known qualifications. This, notwithstanding, those who responded through any of the required postings shall be allowed to participate. Receipt of at least one (1) quotation is sufficient to proceed with the evaluation thereof.
  
- iii. Except for those with ABCs equal to Fifty Thousand Pesos (P50,000.00) and below, RFQs shall be posted for a period of three (3) calendar days in the PhilGEPS website, website of the Procuring Entity, if available, and at any conspicuous place reserved for this purpose in the premises of the Procuring Entity.”

**WHEREAS**, the Requests for Quotations (RFQ) were posted and sent on November 24, 2022 to the following service providers:

1. Center for Global Best Practices Foundation, Inc.;

2. South East Asia Speakers and Trainers Bureau (Jen Angeles and Delia Gauran); and
3. The Talkshop Learning & Training Center.

**WHEREAS**, the following service providers submitted quotations before the deadline of November 29, 2022; 10:00 A.M:

1. Governometrics Management Consultancy Services received on November 29, 2022, 9:47 A.M.;
2. People Summit Training & Consulting, Inc. received on November 28, 2022, 11:15 P.M.;
3. The Talkshop Learning & Training Center received on November 28, 2022, 8:38 P.M.; and
4. Center for Global Best Practices Foundation, Inc. received on November 28, 2022, 4:25 P.M.

**WHEREAS**, the GFPS - TWG determined that the quotation of **Center for Global Best Practices Foundation, Inc.** in the amount of **Pesos: One Hundred Seventy-Six Thousand (Php176,000.00)**, inclusive of applicable taxes to be the **Lowest Calculated and Responsive Quotation** to the requirements of PHILGUARANTEE (copy of the Memorandum dated December 2, 2022 is attached as Annex "A") and recommended to the BAC its award;

**THEREFORE**, in consideration of the recommendation of the GAD Focal Point System (GFPS) - TWG, the Bids and Awards Committee resolved to recommend the approval by the Head of the Procuring Entity of the following:

- a. The use of **Small Value Procurement** for the procurement of **Services of a Training Provider for the Conduct of Anti-Violence Against Women Seminar for its Personnel** with an Approved Budget for the Contract (ABC) of **Pesos: Two Hundred Ten Thousand (Php210,000.00)**, inclusive of applicable taxes; and
- b. The award of contract to **Center for Global Best Practices Foundation, Inc.** for the procurement of **Services of a Training Provider for the Conduct of Anti-Violence Against Women Seminar for its Personnel** in the amount of **Pesos: One Hundred Seventy-Six Thousand (Php176,000.00)**, inclusive of all applicable taxes.
