**WHEREAS**, the GAD Focal Point System (GFPS) - TWG requested the Bids and Awards Committee (BAC) for the procurement of the following items for the **18-day Campaign for the Elimination of Violence Against Women and Children (VAWC)**:

**WHEREAS**, CFA:195-2022 in the amount of **Pesos: Four Hundred Eighty-Six Thousand Four Hundred Seventy (Php486,470.00)**, was issued by the Budget Management Department (BMD) for this purpose;

**WHEREAS**, the requested procurement is included in the Philippine Guarantee Corporation Annual Procurement Plan (APP) for FY 2022 – Updated as of June 30, 2022, viz:

**WHEREAS**, in order to promote economy and efficiency, alternative methods of procurement may be resorted to in accordance with Section 48.1 of the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184 or the Government Procurement Reform Act, such as in this case;

**WHEREAS**, the item to be procured does not exceed the threshold prescribed in Section V.D.8.a.i of Annex H of the 2016 Revised IRR of RA No. 9184;

**WHEREAS**, Section V.D.8.b.ii and iii of Annex H of the 2016 Revised IRR of RA No. 9184 provides that:

- “ii. BAC shall prepare and send the RFQs/RFPs to at least three (3) suppliers, contractors or consultants of known qualifications. This, notwithstanding, those who responded through any of the required postings shall be allowed to participate. Receipt of at least one (1) quotation is sufficient to proceed with the evaluation thereof.
- iii. Except for those with ABCs equal to Fifty Thousand Pesos (P50,000.00) and below, RFQs shall be posted for a period of three (3) calendar days in the PhilGEPS website, website of the

Procuring Entity, if available, and at any conspicuous place reserved for this purpose in the premises of the Procuring Entity.”

**WHEREAS**, the Request for Quotation (RFQ) were posted and sent on November 24, 2022 to the following suppliers:

1. Angels & Shirts, Garment Inc.;
2. Anglowealth Enterprises;
3. Innovation Printshoppe, Inc.;
4. Metrocolor Corporation;
5. Rulujac Enterprise;
6. Tart's Enterprises; and
7. VJ Graphic Arts, Inc.

**WHEREAS**, the following suppliers submitted quotations before the deadline of November 29, 2022; 10:00 A.M:

1. Rulujac Enterprise received on November 29, 2022, 9:49 A.M.;
2. Grafiq Advertising System Corporation received on November 29, 2022, 9:42 A.M.
3. Angels and Shirts Garments, Inc. received on November 28, 2022, 5:13 P.M.; and
4. JPC Medical Equipment and Supplies received on November 28, 2022, 5:00 P.M.

**WHEREAS**, the GFPS - TWG determined that both quotations of Angels & Shirts, Garment Inc. and JPC Medical Equipment and Supplies in the amount of Pesos: Two Hundred Seven Thousand Nine Hundred (Php207,900.00), inclusive of applicable taxes to be the Lowest Calculated and Responsive Quotation to the requirements of PHILGUARANTEE;

**WHEREAS**, item no 5 of the Request for Quotation with Reference No. PSSD/BAC-RFQ No. 2022-160 provides that:

**“In the event two or more bidders were determined to be the Lowest Calculated and Responsive Quotation (LCRQ), the End-user shall roll a dice to break the tie in the presence of the concerned bidder’s representative (physically or via video conferencing). The bidder with the highest number shall be the winning bidder. The absence of the concerned bidder’s representative shall not nullify the proceeding.”**

**WHEREAS**, based on the result of tie-breaking activity conducted on December 6, 2022, with **JPC Medical Equipment and Supplies** getting a score of **eight (8)** while **Angels & Shirts, Garment Inc.** getting a score of **four (4)**, the GFPS – TWG determined that the quotation of **JPC Medical Equipment and Supplies** in the amount of **Pesos: Two Hundred Seven Thousand Nine Hundred (Php207,900.00)**, inclusive of applicable taxes to be the **Lowest Calculated and Responsive Quotation** to the requirements of PHILGUARANTEE (copy of the Memorandum dated December 7, 2022 is attached as Annex “A”) and recommended to the BAC its award;

**THEREFORE**, in consideration of the recommendation of the GAD Focal Point System (GFPS) - TWG, the Bids and Awards Committee resolved to recommend the approval by the Head of the Procuring Entity of the following:

- a. The use of **Small Value Procurement** for the procurement of the following items for the **18-day Campaign for the Elimination of Violence Against Women and Children (VAWC)**, with details as follows:


