**RESOLUTION NO. 2023-015**

**WHEREAS**, the Facilities and General Services Department (FGSD) requested the Bids and Awards Committee (BAC) for the procurement of **Tires and Batteries for PHILGUARANTEE Service Vehicles** with an Approved Budget for the contract (ABC) of **Pesos: One Hundred Nine Thousand Eight Hundred (Php109,800.00)**, inclusive of all applicable taxes;

**WHEREAS**, CFA:013-2023 in the amount of **Pesos: One Hundred Nine Thousand Eight Hundred (Php109,800.00)**, was issued by the Budget Management Department (BMD) for this purpose;

**WHEREAS**, the requested procurement is included in the Philippine Guarantee Corporation Annual Procurement Plan (APP) for FY 2023, viz:

**WHEREAS**, in order to promote economy and efficiency, alternative methods of procurement may be resorted to in accordance with Section 48.1 of the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184 or the Government Procurement Reform Act, such as in this case;

**WHEREAS**, the item to be procured does not exceed the threshold prescribed in Section V.D.8.a.i of Annex H of the 2016 Revised IRR of RA No. 9184;

**WHEREAS**, Section V.D.8.b.ii and iii of Annex H of the 2016 Revised IRR of RA No. 9184 provides that:

- “ii. BAC shall prepare and send the RFQs/RFPs to at least three (3) suppliers, contractors or consultants of known qualifications. This, notwithstanding, those who responded through any of the required postings shall be allowed to participate. Receipt of at least one (1) quotation is sufficient to proceed with the evaluation thereof.
- iii. Except for those with ABCs equal to Fifty Thousand Pesos (P50,000.00) and below, RFQs shall be posted for a period of three (3) calendar days in the PhilGEPS website, website of the Procuring Entity, if available, and at any conspicuous place reserved for this purpose in the premises of the Procuring Entity.”

**WHEREAS**, the Requests for Quotations (RFQ) were posted and sent on February 2, 2023 to the following suppliers:

1. Auto-Phil Marketing Corporation;
2. Batparts Supply Company Inc.; and
3. Markpower Enterprises.

**WHEREAS**, the following suppliers submitted their quotations before the deadline of February 6, 2023; 10:00 A.M.;

1. Equilast Inc. received on February 06, 2023, 9:52 A.M.;
2. GBR-Gen General Merchandise received on February 06, 2023, 9:09 A.M.;
3. MotoParc Vehicle Trading received on February 3, 2023, 5:37 P.M.;
4. Faircare Trading Corporation received on February 3, 2023, 4:50 P.M.;
5. Auto-Phil Marketing Corporation received on February 3, 2023, 10:02 A.M.; and
6. Markpower Enterprises received on February 2, 2023, 11:14 A.M.

**WHEREAS**, the FGSD determined that the proposal of **GBR-Gen General Merchandise** in the amount of **Pesos: One Hundred Four Thousand Nine Hundred Twenty-Two (Php104,922.00)**, inclusive of applicable taxes to be the **Lowest Calculated and Responsive Quotation** to the requirements of PHILGUARANTEE (copy of the Memorandum dated February 7, 2023 is attached as Annex "A") and recommended to the BAC its award;

**NOW THEREFORE**, in consideration of the recommendation of the Facilities and General Services Department, the Bids and Awards Committee resolved to recommend the approval by the Head of the Procuring Entity of the following:

- a. The use of **Small Value Procurement** for the procurement of **Tires and Batteries for PHILGUARANTEE Service Vehicles** with an Approved Budget for the contract (ABC) of **Pesos: One Hundred Nine Thousand Eight Hundred (Php109,800.00)**, inclusive of all applicable taxes; and
- b. The award of contract to **GBR-Gen General Merchandise** for the procurement of **Tires and Batteries for PHILGUARANTEE Service Vehicles** in the amount of **Pesos: One Hundred Four Thousand Nine Hundred Twenty-Two (Php104,922.00)**, inclusive of applicable taxes.




