**RESOLUTION NO. 2023-047**

**WHEREAS**, the Recovery Management Department (RMD) requested the Bids and Awards Committee (BAC) for the **Procurement of Security Services for PHILGUARANTEE's Various Acquired Assets** with an **Approved Budget for the Contract of Pesos: Nineteen Million Three Hundred Ninety Thousand (Php19,390,000.00), inclusive of all applicable taxes;**

**WHEREAS**, CFA:004-2023 in the amount of **Pesos: Nineteen Million Three Hundred Ninety Thousand (Php19,390,000.00)** was issued by the Budget Management Department for this purpose;

**WHEREAS**, the requested procurement is under the approved Philippine Guarantee Corporation Annual Procurement Plan (APP) for FY 2023:

**WHEREAS**, the Invitation to Bid was posted on PHILGUARANTEE and PhilGEPS websites and at PHILGUARANTEE-Jade office bulletin board, for seven (7) calendar days;

**WHEREAS**, in response to the aforesaid invitation, the representatives from the following prospective bidders attended the pre-bid conference on February 28, 2023:

- a. **Grand Meritus Security Agency Inc.**
- b. **Lockheed Federal Security Agency, Inc.**
- c. **ICT Security and Investigation Agency Inc.**
- d. **Lifeguard Archangels Security Agency Corporation**
- e. **Alert Security and Investigation Agency Inc.**

**WHEREAS**, the Bid Bulletin No. 1 and Cost Distribution Form were posted on PHILGUARANTEE and PhilGEPS websites and at PHILGUARANTEE-Jade office bulletin board on February 14, 2023;

**WHEREAS**, the following bidders submitted bid before the deadline on February 21, 2023; 1:15 P.M.;

- a. **Lifeguard Archangels Security Agency Corporation received on February 21, 2023; 9:48 A.M.; and**
- b. **Lockheed Federal Security Agency, Inc. received on February 21, 2023; 11:45 A.M.**



**WHEREAS**, during the opening and preliminary examination of bids on February 21, 2023; 1:30 P.M., both were declared **"PASSED"** on the Technical Components (Eligibility and Technical Requirements);

**WHEREAS**, both Financial Bids were rated **"PASSED"** and read as follows:

**WHEREAS**, on February 28, 2023, based on the bid evaluation and recommendation made by the TWG, the BAC declared the financial bid of **Lockheed Federal Security Agency, Inc. (Lockheed)** in the amount of **Pesos: Eighteen Million Eight Hundred Seventy-Nine Thousand Eight Hundred Sixty-Two and 44/100(Php18,879,862.44)**, inclusive of all applicable taxes as the **Lowest Calculated Bid**;

**WHEREAS**, during the post-qualification on March 13, 28 and April 13, 2023, the BAC determined that there are inconsistencies with the issued and posted bidding documents, hence an intelligent and reasonable evaluation cannot be attained;

**WHEREAS**, Section 20.1.a and 20.1.c.ii of the 2016 Revised Implementing Rules and Regulations of Republic Act No. 9184 provides that:

**"Prior to the advertisement or the issuance of the Invitation to Bid/Request for Expression of Interest for each procurement undertaken through a competitive bidding, the BAC, through its Secretariat, shall call for a pre-procurement conference. The pre-procurement conference shall be attended by the BAC, the Secretariat, the unit or officials, including consultants hired by the Procuring Entity, who prepared the Bidding Documents and the draft Invitation to Bid/Request for Expression of Interest for each procurement. During this conference, the participants, led by the BAC, shall:**

- a) **Confirm the description and scope of the contract, the ABC, and contract duration"**
- c) **Determine the readiness of the procurement at hand, including, among other aspects, the following:**
  - ii) **completeness of the Bidding Documents and their adherence to relevant general procurement guidelines"**

**WHEREAS**, Section 41.b of the 2016 Revised Implementing Rules and Regulations of Republic Act No. 9184 provides that:


“The HOPE reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract in the following situations:

If the BAC is found to have failed in following the prescribed bidding procedures”

**NOW, THEREFORE**, in view of the foregoing circumstances, the Bids and Awards Committee (BAC), hereby **RESOLVE** to recommend approval by the Head of the Procuring Entity for the declaration of a failure of bidding for the **Procurement of Security Services for PHILGUARANTEE’s Various Acquired Assets** with an **Approved Budget for the Contract of Pesos: Nineteen Million Three Hundred Ninety Thousand (Php19,390,000.00), inclusive of all applicable taxes.**


