



## INVITATION TO BID FOR THE PROCUREMENT OF SCANNERS (PGC-BAC-2023-005G); and PROCUREMENT OF DATACENTER UPS (PGC-BAC-2023-006G)

1. The **Philippine Guarantee Corporation (PHILGUARANTEE)**, through the **2023 Corporate Operating Budget** intends to apply the sum of the following Approved Budget for the Contract (ABC) to payments under the contract for each lot:

Lot	Procurement Project	Approved Budget for the Contract (Inclusive of all applicable taxes)
1	Procurement of Scanners/ PGC-BAC-2023-005G	PESOS: Two Million Six Hundred Fifty Thousand (Php2,650,000.00)
2	Procurement of Datacenter UPS/ PGC-BAC-2023-006G	PESOS: Three Million Five Hundred Thousand (Php3,500,000.00)

Bids received in excess of the ABC for each lot shall be automatically rejected at bid opening.

2. The **PHILGUARANTEE** now invites bids for the above Procurement Projects. Delivery of the Goods is required as follows:

1	Procurement of Scanners/ PGC-BAC-2023-005G	Ninety (90) calendar days from receipt of the Notice to Proceed (NTP)
2	Procurement of Datacenter UPS/ PGC-BAC-2023-006G	One Hundred Twenty (120) calendar days from receipt of the Notice to Proceed (NTP)


Bidders should have completed, within **two (2) years** from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).

3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary “*pass/fail*” criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.
- a. Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA No. 5183.
4. Prospective Bidders may obtain further information from **PHILGUARANTEE** and inspect the Bidding Documents at the address given below during **9:00 A.M. to 4:00 P.M.**

5. A complete set of Bidding Documents may be acquired by interested Bidders on **June 8, 2023** from the given address and website(s) below *and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of PESOS: Five Thousand (Php5,000.00) per lot.* The Procuring Entity shall allow the bidder to present its proof of payment for the fees *in person*.
6. The **PHILGUARANTEE** will hold a Pre-Bid Conference<sup>1</sup> on **June 16, 2023; 01:30 P.M.** through video conferencing or webcasting *via Webex*, which shall be open to prospective bidders.
7. Bids must be duly received by the BAC Secretariat manual submission at the office address indicated below, on or before **June 28, 2023; 01:15 P.M.** Late bids shall not be accepted.
8. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB** Clause 14.
9. Bid opening shall be on **June 28, 2023; 01:30 P.M.** at the given address below and/or *via Webex*. Bids will be opened in the presence of the bidders' representatives who choose to attend the activity.
10. The **PHILGUARANTEE** reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Sections 35.6 and 41 of the 2016 revised IRR of RA No. 9184, without thereby incurring any liability to the affected bidder or bidders.
